CASES FOR HEARING

NEW CASES

VARIANCES

V-12-15 Esteban Cordova & Dina Fernandez

Request for variances of 10 feet front yard depth, 6.5 feet side yard width, 17 feet rear yard depth/width, 25.5% net lot coverage; variances of 3.5 feet front street line and 1.5 feet side lot line setbacks and a waiver of the rear yard location requirement for an accessory building; and waivers of the fence location and height requirements for a fence in the front yard to validate existing conditions and obtain a building permit for a covered front porch, covered rear porch, attached carport, driveway, shed, 6-foot black iron rail fence, 5-foot grey aluminum mesh fence and 4.5-foot black iron rail fence (with 5.4-foot and 6.5-foot stone columns) at 1216 Devonshire Drive, Oxon Hill. **Petitioners submitted a revised site plan. It was determined that readvertisement of the variance request is necessary and 6/24/15 was confirmed as a new hearing date. Petitioners shall be required to pay readvertising and reposting fees.**

V-44-15 Timothy & Rachiel Durant

Request for variances of 7 feet side yard width and 1.7% net lot coverage to validate existing conditions and construct a screened porch at 5416 20th Avenue, Hyattsville. **Petitioners withdrew the variance request. The Board resolved, unanimously, that the appeal be DISMISSED.**

V-27-15 Vance Parker

Request for a waiver of the parking area location requirement and a variance of 2 feet setback from an alley for an accessory building to validate an existing condition and construct a driveway in the front yard at 6531 Halleck Street, District Heights. **The Board resolved, unanimously, that a waiver of the parking area location requirement and a variance of 2 feet setback from an alley for an accessory building be APPROVED. Approval of the variances is contingent upon development in conformance with the approved site plan, Exhibit 2.**

V-33-15 Good Knight Child Empowerment Network, Inc.

Request for waivers of the fence location and height requirements to obtain a building permit to replace an 8-foot plywood privacy fence with an 8-foot vinyl privacy fence at 11001 Rhode Island Avenue, Beltsville. **The record shall remain open for technical assistance.**

V-43-15 Maria Martinez & Leonel Herrera

Request for variances of an additional 1.5 feet side yard width and an additional 1 foot rear yard depth/width for the dwelling, 13.9% net lot coverage and a waiver of the rear yard location requirement for an accessory building to validate existing conditions and construct a carport with a deck on top at 5022 53rd Place, Hyattsville. **Spanish language translation services were provided. The Board resolved, unanimously, that variances of an additional 1.5 feet side yard width and an additional 1 foot rear yard depth/width for the dwelling, 13.9% net lot coverage and a waiver of the rear yard location requirement for an accessory building be DENIED.**

V-36-15 Keith Winston

Request for variances of 15 feet front yard depth, 2 feet side yard width and 7.7% net lot coverage to validate existing conditions to obtain a new building permit to complete the renovation of a two-story frame dwelling and driveway at 3725 Wells Avenue, Mount Rainier. **The record was held open to allow the City of Mount Rainier the opportunity to comment on the request.**

V-37-15 Ricardo & Herminio Portales

Request for a waiver of the parking area location requirement to construct a driveway in the front yard at 6216 Quebec Street, College Park. **The record was held open to allow Petitioners the opportunity to discuss the request with the Town of Berwyn Heights, Petitioners to submit a revised site plan and the Town to submit revised comments.**

V-39-15 Vincent & Haydee Estrella

Request for a variance of 10 feet rear yard depth/width to construct a deck with landing and steps to replace an existing deck at 7007 Shagbark Court, Fort Washington. **The record was held open for Woodside Homeowners Association's approval of the request.**

V-40-15 John & Gwendolyn Franklin

Request for a variance of 2 feet side yard width to construct a deck which includes covered patio area, covered spa area and covered cooking area at 14408 Waynesford Drive, Upper Marlboro. **The Board resolved, unanimously, that a variance of 2 feet side yard width be APPROVED. Approval of the variance is contingent upon development in conformance with the approved site plan, Exhibit 2, and the approved elevation plan, Exhibit 3.**

Approval of the variance is contingent upon development in conformance with the approved site plan, Exhibit 2.**
