RESOLUTION

1 A RESOLUTION concerning

2 2025-2026 Compensation Review Commission

3 For the purpose of establishing a Compensation Review Commission to undertake a
4 comprehensive study and make recommendations regarding the compensation and allowances of
5 the County Council Members and County Executive, and generally relating to the Compensation
6 Review Commission.

7 WHEREAS, Section 308 and Section 406 of the Charter of Prince George's County,
8 Maryland provide for the appointment of a compensation review commission by the Council and
9 County Executive; and

10 WHEREAS, Section 10-302, Local Government I Article, Annotated Code of Maryland
11 provides that by ordinance, a county may establish a commission to recommend compensation
12 and allowances for members of the county legislative body; and

13 WHEREAS, Section 10-303, Local Government I Article, Annotated Code of Maryland
14 provides that the county may set the qualifications, term of office, and compensation for the
15 County Executive.

16 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
17 County, Maryland, that the 2025-2026 Compensation Review Commission is hereby created.

18 BE IT FURTHER RESOLVED that the 2025-2026 Charter Review Commission shall
19 consist of seven (7) citizens, three (3) appointed by the County Executive and three (3) appointed
20 by the County Council and one (1) Chairperson who shall be jointly agreed upon by the County
21 Executive and the Chairperson of the County Council.

1 BE IT FURTHER RESOLVED that the 2025-2026 Compensation Review Commission
2 shall consist of the following seven citizens: Gloria G. Lawlah, Maurice Simpson, Jr., Steven L.
3 Taylor, appointed by the County Council, and L. Denise Hall, Arthur J. Horne, Jr., Jacqueline B.
4 Woody, appointed by the County Executive; and Chair Camille A. Exum, jointly agreed upon by
5 the County Executive and the Chair of the County Council.

6 BE IT FURTHER RESOLVED that appointees to the 2025-2026 Compensation Review
7 Commission will also serve as members of the 2025-2026 Charter Review Commission.

8 BE IT FURTHER RESOLVED pursuant to Sections 308 and 406 of the Prince George's
9 County Charter, a compensation review commission shall be appointed not later than one year
10 prior to the beginning of each fourth year of a term, by ordinance, by the Council and the County
11 Executive to recommend compensation and allowances for Council members and the County
12 Executive.

13 BE IT FURTHER RESOLVED that the County Council shall provide appropriate staff and
14 clerical support for the 2025-2026 Compensation Review Commission.
