Art Works Now	\$2,500	Art Works Now will use the grant funds to provide critical support to subsidized program/operational costs so AWN can continue to provide meaningful arts education that positively impacts/enriches the lives of the participants of all ages, especially those of the most vulnerable populations across PGC.
Bowie Business Innovation Center (Bowie BIC)	\$10,000	Bowie Business Innovation Center (Bowie BIC) will use grant funds to support our Open Door series and Bowie BIC on the Move, an extension of their Open-Door program. Funds will help cover operational expenses and supplies.
Bowie CLAW	\$4,500	Bowie Citizens for Local Animal Welfare, Inc. (CLAW) will use grant funds to provide food, supplies and veterinary care for adoptable cats and kittens surrendered, or found when trapped through the Trap, Neuter, Return (TNR) program.
Bowie Community Theatre	\$5,000	Bowie Community Theatre (BCT) will use grant funds to cover an operating deficit for the current fiscal year. They are struggling especially with rapidly escalating costs to rehearse and perform at the Bowie Playhouse.
Champ House Recovery, Inc.	\$10,000	Champ House will use grant funds to replace the flooring in the common room area as well as repair and replace flooring in hallway from the common area to the kitchen and laundry room. As well as, replace the steps from the common area to the hallway and install bi-fold doors and paint all areas.
City of Greenbelt (ACE)	\$2,500	City of Greenbelt Advisory Committee on Education (ACE) oversees a college scholarship fund for high achieving high school students, will award grant funds to high school seniors for college related expenses.
City of Greenbelt (CARES)	\$5,000	City of Greenbelt CARES will use grant funds to provide mental health counseling, GED, and tutoring services to youth and families free of charge.
City of Greenbelt (Emergency Asst. fund)	\$4,000	City of Greenbelt Emergency Assistance Fund will use grant funds to assist residents facing eviction from their home.
End Time Harvest Ministries	\$2,000	End Time Harvest Ministries will use the grant funds to fund the Pathways to Career Success Program that graduates students on time college, career, and workforce ready. These funds will also fund student scholarships and summer internships.
Food & Friends, Inc.	\$5,000	Food & Friends will use the grant funds to provide freshly prepared home delivered Medically Tailored Meals, Groceries and Medical Nutrition Therapy to neighbors living with serious illnesses such as diabetes, heart disease, HIV/AIDS, sickle cell, etc. who cannot shop or cook for themselves.
Greater D.C. Diaper Bank	\$3,000	Greater D.C. Diaper Bank will use grant funds to purchase diapers and, via social service programs, distribute them for free directly to Prince George's County families in need, increasing their engagement in our partners proven interventions.
Higher Achievement Program, Inc.	\$2,000	Higher Achievement Program, Inc. will use grant funds to bridge the opportunity gap in Prince George's County during the critical middle school years. Grant funding will also support academically rigorous out of school time programming for 50 scholars at our Greenbelt Achievement Center.
Interfaith Coalition of Bowie	\$4,000	Interfaith Coalition of Bowie will use grant funds to host two interfaith socials/trivia nights to foster relationship building and understanding of different faith traditions.
It Takes a Village Collaborative	\$2,500	It Takes A Village Collaborative will use grant funds to support hybrid wellness initiatives in Prince George's County, providing women, including justice-impacted, potential individuals, with 25 hours of free wellness and mental health support, and aiming to assist 150 additional residents in 2025.
