In 2024, over 2,700 participants, 80 businesses, participated in a full day of activities.
ARAMIDE Gives	\$2,000	ARAMIDE Gives will use grant funds to provide youth with opportunities to grow, learn, and develop important skills that will shape their future. ARAMIDE Gives aims to equip the next generation with the tools needed to succeed and reach their full potential.
Beltsville Community Cats, Inc.	\$2,000	Beltsville Community Cats, Inc. will use the grant funds to spay/neuter, vaccinate, combo test and microchip abandoned house cats and to address illnesses and injuries for sick and or injured community cats.
Beltsville Seventh-day Adventist Church	\$10,000	Beltsville Seventh-day Adventist Church will use the grant funds to purchase and distribution of 550 Thanksgiving Turkey Baskets to District One Families in need.
Cherry Lane Boxing and Youth Fitness Inc.	\$4,000	Cherry Lane Boxing and Youth Fitness Inc. will use grant funds to purchase the necessary boxing equipment and cleaning supplies for participants. The funds will allow families that lack the financial capacity the ability to get their kids started in an activity.

The grant will cover equipment and software for production of student-produced announcements to be broadcast to classrooms.

Laurel Cats, Inc.	\$2,000	Laurel Cats, Inc. will use grant funds to cover medical expenses for cats belonging to or cared for by low-income residents of Prince George's County or cats found abandoned in Prince George's County.
Laurel for the Patuxent	\$2,800	Laurel for the Patuxent will use grants funds to expand their successful outreach and engagement program that provides opportunities for people of all ages and backgrounds to participate in environmental stewardship in Prince George's County and across the Patuxent Watershed.
Liberty's Promise, Inc.	\$3,000	Liberty's Promise, Inc. will use grant funds to support our after-school programs of civic engagement, held at Parkdale High School and Charles Carroll Middle School, held twice annually, in 10-week sessions, running from March to May and again from October to December.
Meals on Wheels of the College Park Area, Inc.	\$3,000	Meals on Wheels of the College Park Area, Inc. will use grant funds to purchase food items to assist with the preparation of meals for our clients.

Peace on Patuxent Inc.	\$5,000	Peace on Patuxent Inc. will use the grant funds for operational expenses, to cover the salary of an Office Manager, which will assist our organization to ensure that all services remain accessible and free of charge to women diagnosed with life-leveling cancers.

They work with school community liaisons to identify food insecure students to provide meals for them over the weekend during the school year.
