<a href="#">Community Legal Services of Prince George County</a>	\$5,000	Community Legal Services of Prince George's County, Inc. will use grant funds to provide mobile legal services to reach under-served areas of the county lacking access to legal services. Legal matters include domestic violence, estate planning for seniors, expungement, family law, and other civil legal matters.
<a href="#">Court Appointed Special Advocate Prince George's County</a>	\$5,000	Court Appointed Special Advocate Prince George's County will use grant funds to advocate for the physical health, mental health, safe housing, educational and social needs of 190 foster youth. Grant funds will support managing volunteers from throughout the County to be matched with youth who come from every district in the County.
<a href="#">Edward Charles Foundation</a>	\$50,000	Edward Charles Foundation, Community on the Frontlines Program will use grant funds to provide key community services to the children, residents, and seniors in District 7.
<a href="#">Homeless Children's Playtime Project</a>	\$5,000	Homeless Children's Playtime Project will use the grant funds to support trauma-informed play programs and camps for children experiencing homelessness and housing insecurity at Playtime's programs in Prince George's County. In 2024, we served more than 225 Prince George's County children.
<a href="#">Maple Springs Community Services Corporation</a>	\$10,000	Maple Springs Community Services Corporation will use grant funds to augment the Christian Aid Resources Exploration (CARE) Program, providing emergency assistance with mortgage, rent, and utility payments. Ruby's House helps families in need, during the Christmas providing gifts and food.

To empower the community with much needed assistant of food, shelter and utilities assistant to live adequately
<a href="#">Stillborn And Infant Loss Support</a>	\$5,000	Stillborn And Infant Loss Support will use grant funds to cover the cost of one co-hort group, program supplies, outreach and refreshments while conducting (4) 8-week Grief Recovery program, co-hort style, for parents who have experienced pregnancy or infant loss.
