Africa Environmental Watch & Services	\$3,000	Africa Environmental Watch & Services will use the grant funds to develop a green learning agenda for communities in Districts across Prince George's County that are stewards of stormwater ponds
BCAUSEICAN, Inc.	\$5,000	BCAUSEICAN, Inc. will use grant funds to achieve the goals of its high impact STEM programming delivered at Prince George's County Public School sites, BCAUSEICAN will need to purchase software, equipment and compensate its staff.
Bishop McNamara High School	\$5,000	Bishop McNamara High School, Inc. will use the grant funds to provide essential assistance to students whose families are facing financial hardship. Funds will help cover critical expenses such as tuition, student fees, books, SAT/ACT workshops or testing fees-ensuring that students can continue their education.
C&J Migrant Solutions Foundation Inc	\$5,000	C&J Migrant Solutions Foundation Inc. will use grant funds to sustain and expand their ESL and citizenship classes, while also establishing a Technology Lab and GED program. These initiatives aim to empower the migrant community by addressing gaps in education and equipping individuals with critical skills.
Community Health Foundation Inc.	\$3,500	Community Health Foundation Inc. will use grant funds to rent a larger space to accommodate the growing demand for food assistance, purchase cold storage units to preserve perishable food and acquire vehicles to deliver food to individuals who are handicapped or unable to afford transportation to the pantry.
Court Appointed Special Advocate Prince George's County	\$3,000	Court Appointed Special Advocate Prince George's County will use grant funds to advocate for the physical health, mental health, safe housing, educational and social needs of 190 foster youth. Grant funds will support managing volunteers from throughout the County to be matched with youth who come from every district in the County.
Engaged Community Offshoots, Inc. dba ECO City Farms	\$3,000	Engaged Community Offshoots, Inc. dba ECO City Farms will use grant funds to support the salaries of their farmers who grow food for the local community.
Greater D.C. Diaper Bank	\$5,000	Greater D.C. Diaper Bank will use grant funds to purchase diapers and, via social service programs, distribute them for free directly to Prince George's County families in need, increasing their engagement in our partners proven interventions
Greater Saint John Catherdal	\$10,000	Greater Saint John Church, Inc. will use the grant funds to serve God through community service to impact over 30,000 lives.
Junior League of Prince George's County Inc.	\$2,000	Junior League of Prince George's County Inc. will use grant funds to empower women by helping them develop civic leadership skills, giving them the tools to put their unique talents to work in our community, and working with youth especially around literacy.
Prince George's Cultural Arts Foundation, Inc.	\$10,000	Prince George's Cultural Arts Foundation will use grant funds to support the Lake Arbor Jazz Festival, where proceeds benefit the Price George's Cultural Arts Scholarship Fund. Scholarships are awarded to college students furthering their education in the arts. Scholarships cover tuition, books, room and board.
Queens Care HOLLA	\$5,000	Queens Care HOLLA will use grant funds to help the low and impacted senior communities in need of food to stay healthy and active. With services to age in place and to keep them engaged with training, activities, events and information to help and build strong and thriving communities.
Re-Entry Roundtable for Prince George's County	\$6,500	The Re-Entry Roundtable for Prince George's County will use the grant funds to support the stabilization of adult male returning criticsizes. Specifically, funding to support a contracted in-take navigator and to provide supplemental support for the cost of wrap-around services.
Special Care for Special Needs Dentistry, Inc	\$7,000	Special Care for Special Needs Dentistry, Inc. will use the grant funds to serve the dental health interest of the special needs community in the Greater Washington DC region to advance their oral health and to foster the proficiency of the special needs dentist through quality training.
