Art Works Now	\$4,000	Art Works Now will use the grant funds to provide critical support to subsidized program/operational costs so AWN can continue to provide meaningful arts education that positively impacts/enriches the lives of the participants of all ages, especially those of the most vulnerable populations across PGC.
BCAUSEICAN, Inc.	\$3,000	BCAUSEICAN, Inc. will use grant funds to achieve the goals of its high impact STEM programming delivered at Prince George's County Public School sites, BCAUSEICAN will need to purchase software, equipment and compensate its staff.
C&J Migrant Solutions Foundation Inc	\$4,500	C&J Migrant Solutions Foundation Inc. will use grant funds to sustain and expand their ESL and citizenship classes, while also establishing a Technology Lab and GED program. Community Legal Services of Prince George County	\$5,000	Community Legal Services of Prince Gerorge's County, Inc. will provide mobile legal services to reach under-served areas of the county lacking access to legal services. Legal matters include domestic violence, estate planning for seniors, expungement, family law, and other civil legal matters.
Community Youth Advance	\$3,500	Community Youth Advance, Inc. will use the grant funds to deliver year-round quality academic enrichment, mentoring, and college and career readiness activities that promote academic excellence, promote character and prepare youth to meet life's challenges.
Court Appointed Special Advocate Prince George's County	\$4,000	Court Appointed Special Advocate Prince George's County will use grant funds to advocate for the physical health, mental health, safe housing, educational and social needs of 190 foster youth. Grant funds will support managing volunteers from throughout the County to be matched with youth who come from every district in the County.
Ebenezer COG Community Outreach Ministries	\$1,000	Ebenezer COG Community Outreach Ministries will use the grant funds to assist with the 9th Annual Save A City Event which provides Free Groceries, Free Health Care Screenings and Free Back to School Supplies for over 1300 patrons. Also to assist with procuring supplies for our weekly food pantry that serves over 350 families weekly.

Institute for Public Health Innovation (Food Equity Council)	\$2,500	Institute for Public Health Innovation (Food Equity Council) will use the grant funds to coordinate with Feasibility Consultant and serve as a member of the core team to guide the implementation of the feasibility study and business plan. This includes providing technical assistance, relationship management, leveraging resources and assisting with identifying members to serve on the coordination committee.
International Rescue Committee Inc. (IRC)	\$2,000	International Rescue Committee Inc. (IRC) will use the grant funds to expand its 2GEN program, offering various ESL and school readiness classes. The inclusive program will serve diverse backgrounds, adding intermediate English sessions, strengthening learning through a 12-week partnership course.
La Clinica del Pueblo, Inc.	\$1,500	La Clinica del Pueblo, Inc. will use grant funds to meet the healthcare needs of Latino families in Prince George's County through the provision of comprehensive primary care and mental health services that are culturally and linguistically appropriate for low-income, uninsured, LEP residents.
Latin American Youth Center	\$4,000	Latin American Youth Center will use the grant funds to support the Latin American Youth Center/ Maryland Multicultural Youth Center's (LAYC/MMYC) Prince George's County programs such as afterschool tutoring and academic enrichment, summer camps, housing, GED classes, and workforce development programs.
Liberty's Promise, Inc.	\$5,000	Liberty's Promise, Inc. will use grant funds to support our after-school programs of civic engagement, held at Parkdale High School and Charles Carroll Middle School, held twice annually, in 10-week sessions, running from March to May and again from October to December.

The Neighborhood Design Center	\$4,000	The Neighborhood Design Center seeks funding to advance its mission of fostering healthy, equitable neighborhoods by providing pro bono design services to community partners in Prince George's County.
The Training Source Inc.	\$1,500	The Training Source Inc. will use grant funds for adult job training, youth leadership; youth job readiness training; college and career planning; community support services (SNAP application assistance, domestic violence survivor support etc.); employer staffing and training etc.
WETATi Academy, Inc	\$1,000	WETATi Academy, Inc will use the grant funds to implement WETATi Academy's practical entrepreneurship education programs, which focus on financial literacy, entrepreneurship, workforce development & STEM. The program is designed to equip low-to-moderate income youth and community members with essential skills and knowledge to foster economic empowerment.
