### Organizational Structure

The Office consists of the Director, and six full-time support staff, including one attorney, one investigator, and a compliance specialist. The Office supports the Board of Ethics, which has five members, including the Chair.

### FY 2026 Top Priorities

- Continue to maintain the County's electronic filing/case management system that allows Prince Georgians, County government employees and elected/appointed officials 24/7/365 access to online filing of complaints, required financial disclosure statements and lobbyist registrations/annual reports. Efficiently investigated all complaints in accordance with applicable laws to ensure timely responses, analysis, reporting and recommendations to management.

### BACKGROUND

Prince George's County created the Office of Ethics & Accountability ("OEA") in 2012 to provide increased accountability and oversight of operations of the County Government and in response to several public corruption incidents. OEA provides ethics advice, conducts training, provides public outreach/education, and investigates alleged complaints involving ethics violations and fraud, waste, abuse, and illegal acts (FWAI) by non-law enforcement County officials/employees, companies doing business with the County, or involving County services. In addition, OEA supports the County Board of Ethics, a five member appointed citizen body, in exercising authorities granted to it under the Prince George's County Code of Ethics to promote the public's trust in County Government, including ensuring the reporting of financial disclosure by County elected members, officials, and employees, requiring lobbyists to register and report applicable lobbying activities, reviewing secondary employment requests and in final determinations and enforcement in ethics violation cases.


