STAFF REPORT

OVERVIEW

The Prince George's County Public School System (PGCPS) serves approximately 133,000 students, an increase of over 1,900 students from last year's population. During FY 2018, inventory will include 208 facilities.

The County Executive's proposed FY 2018-2023 *six-year* Capital Improvement Program (CIP) for the Board of Education (BOE) totals \$2.02 billion in appropriations. The proposed level of funding for FY 2018 will support a total of 60 projects.

The proposed FY 2018 Capital Budget represents the *current year* of the six-year Board of Education Capital Improvement Program with a total of \$125.7 million, a decrease from the \$147.4 million in projected spending last fiscal year. The FY 2018 funding sources include \$100.6 million in General Obligation Bonds (GOB), \$21.8 million in State Aid and \$3.3 million in Other Aid.

Note: The FY 2018 Approved County CIP for the Board of Education will be amended based on the final state funding award.

STATE FUNDING

FY 2018 Recommended State Funding

This past November, the County requested \$78.5 million in funding from the Maryland Public School Construction Program (**See Attachment A**). It is important to note that pursuant to HB 151 of 2017 (Chapter 22), the Maryland Consolidated Capital Bond Loan (MCCBL) of 2017, allocations of funding for public school construction are now made by the Interagency Committee on School Construction (IAC) without the approval of the Board of Public Works (BPW).

On May 2, 2017, the IAC provided additional approval for \$16.2 million which brought the total amount to \$37.0 million. Additional funds came from the Supplemental Capital Grant Program for Local School Systems with Significant Enrollment Growth or Relocate-able Classrooms (EGRC) in the amount of \$12.6 million. In the end, the PGCPS received a total of \$49.6 million from the State, an increase from the FY 2017 level of \$39.9 million.

Taking into account the IAC allocations, the state-wide Maryland Public School Construction Program totals \$392.4 million for specific projects among 22 public school jurisdictions in Maryland. Of this amount, \$280 million consists of FY 2018 Capital Bond funds supplemented by \$43.2 million in Prior Year CIP Reserved for specific Local Education Agencies (LEAs) Contingency and ACI Funds, \$244,000 in Unreserved Prior Year CIP Reverted Contingency Funds, \$63.9 million in EGRC Funds and \$5.0 million in Fund Adjustment to the FY 2017 CIP for Baltimore County. To date, the IAC has recommended funding approval for 197 projects state wide. (See Attachment B)

Interagency Committee on School Construction Annual Funding Process

Robert A. Gorell is the Interagency Committee on School Construction (IAC) Executive Director. Each fall, the 24 school systems in the State submits an annual and Six Year Capital Improvement Program which is approved by the local school districts. Following a comprehensive review with representatives of the school districts and relevant State agencies (i.e. MDOT, MDP) state agency staff provides recommendations to the IAC. In December, the IAC holds an appeals hearing with the local school districts.

In the past, The Capital Improvement Program, as recommended by the IAC, was preliminarily approved by the BPW. However, as stated previously, the structure of the State funding approval process has been modified pursuant to the MCCBL of 2017 to allow for funding allocation by

the IAC without approval by the BPW. Funding decisions are finalized in May/June. Listed below are capital budget process dates:

- October 5 – LEA submission of the capital budget to the State Interagency Committee
- October 11 – October 31 - PSCP staff interviews individual LEA
- November 17 - Public School Construction staff recommendations to the IAC
- **November 28 - County Government's joint signature letter due to the IAC**
- December 13 - IAC hearings on the CIP requests
- December 30 - IAC recommendation on 75% of proposed FY2017 capital budget submitted to Board of Public Works
- January 27 - State Board of Public Works appeals hearing and approval of initial projects
- February 27 - IAC recommends 90% of the proposed state capital budget to the State Board of Public Works
- May 13 – IAC approves 100% of state funding (per HB 151 of 2017)
- June – PSCP releases the final FY2018 Capital Improvement Program approved by the IAC
- July 1 - Funds Available

Capital Budget

FY 2018 Capital Budget Overview

The County proposes to make significant investments in a number of school construction projects within the FY 2018 Proposed Capital Budget for the Board of Education, including \$125.7 million in capital funds to support such projects. During FY 2018, the construction phase of Fairmont Heights High and Glenarden Woods Elementary will be completed, while the planning phase for the renovation/replacement of Suitland High and the construction of the International School at Langley Park will commence. While there have been delays in the project timeline, Tulip Grove Elementary is anticipated to completed prior to August 2018.

The most significant Capital Budget increases from the FY 2018 Proposed Capital Budget to the FY 2017 Approved Capital Budget occurs for the following school projects:

- William Schmidt Educational Ctr. \$10.2 million increase, or 61%;
- Central Garage/Transp. Dept. \$ 4.0 million increase, or 26%;
- Roger Heights ES \$ 6.2 million increase, or 22%.

The most significant Capital Budget decreases from FY 2018 Proposed Capital Budget to the FY 2017 Approved Capital Budget occurs for the following school projects:

• Longfield ES	\$26.4 million decrease, or 52%;
• Apple Grove ES	\$13.8 million decrease, or 37%;
• Cherokee Lane ES	\$14.3 million decrease, or 36%;
• Potomac Landing ES	\$13.0 million decrease, or 35%;
• Benjamin Tasker MS	\$ 5.9 million decrease, or 30%;
• Hyattsville ES	\$ 8.1 million decrease, or 25%;
• Bowie HS Annex	\$ 5.5 million decrease, or 23%.

The two main reasons for the changes in cost estimates are:

- a) Change in Project Scope where renovation projects now include cost estimates for full replacement.
- b) State rate changed where the State reduced the cost per square feet construction rate for addition or renovation from \$282/ sq. ft. in FY 2017 to \$265/ sq. ft. in FY 2018.

The FY 2018 Proposed Capital Budget consists of the following school construction and renovation/rehabilitation projects as listed below, as provided in the FY 2018 – FY 2023 Proposed Capital Budget and Program, Volume 1. For additional details, see **Attachment C**.

The following projects are anticipated to be funded by *annual local gaming revenue*, as reported by the Board of Education:

- Crossland HS Steam Piping Replacement is being executed under the approved State-funded FY 2017 project by the same name for \$1.28 million, as the actual cost exceeds the original estimate. The Board of Education would like to re-allocate local gaming revenue for this project to be used for replacement of the Crossland HS track to correct an unusable condition, at an estimated project cost of \$460,000. It is planned for execution over the summer of 2017 and will be supported with FY 2017 and FY 2018 VLT proceeds.
- Forest Heights ES Code Correction is not yet assigned a Project Manager due to vacancies in the Department's Capital Programs. The generator may be installed by the Department of Building Services in the summer of 2017 with fire alarm work to follow.
- Fort Foote ES Exterior Door Replacement is in scope development.
- Glassmanor ES Window Wall Replacement/Resurface Parking Lots may be executed the summer of 2017 by the Department of Building Services. There is currently enough funding to resurface the parking lot, but not to replace the window system.
- Potomac Landing ES Code Correction and the Playground Equipment/Fire Alarm/Parking Lot is insufficiently funded at \$195,000 to replace the playground equipment fire alarm and parking lot. However, the priority work of the fire alarm replacement may be executed under the State and County-funded Open Space Pod Conversion approved in FY 2015 CIP. The playground may be replaced under these funds by the Department of Building Services during the summer of 2017.
- Princeton ES and Tayac ES Code Correction and Fire Alarm Replacement is not yet assigned a Project Manager due to vacancies in the Department's Capital Program. However this is a priority project and the fire alarm replacement will be expedited. It may be designed and installed in parallel with the existing system, or scheduled in the summer of 2018.
- Thurgood Marshall MS Exterior Repairs/Cameras had a site visit with the security vendor for installation in the summer of 2017. The exterior repair work will be executed under the State and County-funded Window and Door Replacement project approved in the FY 2016 CIP. The schedule of this portion of the work is subject to additional funding in FY 2018.

PGCPS reports the *completion* of the following CIP projects during FY 2017:

- Eugene Burroughs MS Renovation
- Glenarden Woods ES Renovation
- Henry Ferguson ES Replacement
- Kenmoor ECC
- Open Space Pod Conversions

The following projects approved in a previous fiscal year's Capital Budget are *delayed*, or are facing delay.

- Bowie HS Annex is currently on schedule, but face imminent delays due to funding. The project is anticipated to be bid in the fall of 2017.
- District Heights ES and Walker Mill MS Kitchen Renovation: Projects are delayed for 12 months. The County-funded FY 2016 projects were scheduled for execution in the summer of 2016, but the contractor defaulted and a new award will be made in the summer of 2017.
- Thomas Pullen Academy and Thurgood Marshall MS Window/Door Replacement: Project are delayed by 9 months. The State and County funded FY 2016 projects require additional funding and an additional request was included in the FY 2018 CIP budget in order to continue.
- Northwestern HS Fireproofing Correction is delayed by 18 months. Emergency/major repairs require additional funding to address the failing fireproofing.
- Bladensburg HS HVAC Correction: Project is delayed by 24 months. The chiller providing heating and cooling has failed and the monthly rental of temporary units are quickly exceeding the cost of replacement.

Other CIP Items

In addition to the new construction projects and systematic repairs to existing facilities, the proposed FY 2018 – FY 2023 *six-year* Capital Improvement Program provides for the following:

- Land Acquisition provides funds for the acquisition of private property to be used for school sites at approximately \$12 million over the next six years.
- Planning Approval provides funds for assembling the documents required to obtain state planning approval for future school capital projects; including, conducting studies to verify needs, determine project scope and preliminary budgets. Included in the FY 2018 GOB funding is \$250,000 for planning approval for a new elementary school in the Fairwood Community and \$250,000 for a feasibility study for a new park-school to be integrated with a new Maryland-National Capital Parks and Planning Commission (M-NCPPC) community center currently under construction on the north side of Westphalia Road to be called the Westphalia Elementary Park School.
- Forward Funded Projects is a placeholder that requests State reimbursement of County funds used to construct eligible school construction projects for which State funds have not yet been allocated. Details of forward funded projects are contained in the chart below.

Dear Mrs. Schaefer:

The purpose of this joint signature letter is to fully endorse the Prince George's County Board of Education's proposed FY 2018 capital budget request and to identify the projects that this County considers most critical. This funding endorsement is consistent with the County's priorities – construction funding for projects that have received State planning approval, approval of planning requests, support for systemic replacements, renovation projects, and reimbursement for forward funded projects.

The Board's FY 2018 funding request of \$78.5 million addresses the many needs faced by our County's schools such as the completion of previously approved projects and critical systemic repair projects of which some have been expanded to be more holistic. It also reflects the advancement of a comprehensive modernization program (estimated at \$8 billion and contained within the FY 2017 Educational Facilities Master Plan) aimed at improving both the physical condition and education adequacy through space for enhanced educational programming. The County supports the Board's FY 2018 funding request.

The first priority is to request State funding for those projects that have received State planning approval. These projects include:

On May 2, 2017, the Interagency Committee on School Construction (IAC) met to consider the final approvals for the Fiscal Year 2018 Public School Construction Capital Improvement Program (CIP). This letter is to inform you of the IAC planning and funding approvals of school construction projects throughout the State of Maryland.

The IAC approvals are based on the approved Maryland Consolidated Capital Bond Loan (MCCBL) of 2017 capital budget, which authorizes \$285 million for the Public School Construction Capital Improvement Program with \$5 million of this authorization being restricted for the sole purpose of increasing State funding for Baltimore County Public Schools to replace funds withheld by the Board of Public Works in Fiscal Year 2017. A \$5 million reduction to MCCBL of 2016 (FY 2017), Chapter 27 of the Acts of the General Assembly of 2016 was authorized, thereby reducing the total authorization for the FY 2017 CIP from \$280 million to \$275 million. The MCCBL of 2017, Chapter 22 also provided that \$5 million in funds from the fiscal 2017 Statewide Contingency Account reserved for Baltimore City Public Schools be allocated to address air conditioning projects in Baltimore City Public Schools.

The IAC's FY 2018 CIP Planning and Funding Approvals totaling \$387.4 million are categorized as follows:
