

He also served as vice-chair of the Council's Health, Education and Human Services committee and chair of the Rules and General Assembly Committee. Also in Legislative Year 2015, Chair Davis served as the Council liaison to the Board of Education; Council representative to the Economic Development Corporation Board of Directors; Prince George's County Conference and Visitors Bureau; a member of the Council of Governments' Transportation Planning Board; and as an alternate board member for the Dimensions Healthcare System

The Honorable Todd M. Turner served as vice-chair of the Council's Transportation, Housing and Environment committee; vice-chair of the Council's Rules and General Assembly committee and as a member of the Council's Public Safety and Fiscal Management (PSFM) committee. In Legislative Year 2015, Council Member Turner also served as the Council representative to the Transportation Planning Board and was appointed to serve as the Council representative to the Maryland Association of Counties.

The Honorable Andrea C. Harrison chaired the Council's Planning, Zoning and Economic Development committee; vice-chair of the Public Safety and Fiscal Management committee; and as a member of the Council's Rules and General Assembly committee in Legislative Year 2015. Council Member Harrison was also appointed to serve on the Metropolitan Council of Governments' Board of Directors; on the Dimensions Healthcare System Board and as the Council representative on the Mental Health Advisory Board.

The Honorable Karen R. Toles served as chair of the Council's Health, Education and Human Services committee, and as a member of the Council's Planning, Zoning and Economic Development committee in Legislative Year 2015. Council Member Toles was also appointed to serve on the Metropolitan Council of Governments' Board of Directors; as a member of the Council of Governments' Region Forward Coalition; as Council Representative to the Parks and Recreation Advisory Board; and as Council Representative to the Prince George's County Health Department.

The Honorable Obie Patterson served as chair of the Council's Public Safety and Fiscal Management committee in Legislative Year 2015. He also served as a member of the Council's committees on Health, Education and Human Services, and Rules and General Assembly. Council Member Patterson was appointed to serve as the Council Representative to the Chesapeake Bay and Water Resources Policy Committee; the Prince George's Board of Social Services; and the Prince George's County Community Foundation.

COMMITTEE ASSIGNMENTS2015

County Council Legislation Begins in the Standing Committee Meetings



From the \$1.3 Billion MGM National Harbor Destination Resort that rises from the County's southern gateway to securing the \$3 Billion Purple Line that will begin construction right here in Prince George's County; from the \$650 Million Regional Medical Center slated for Largo to competing for the \$2 Billion FBI Headquarters in Greenbelt or Landover, our County is doing Big Things on Purpose. This progress is reflected in the leadership and thoughtful work of Council committees over the past year.

The Council's Planning, Zoning and Economic Development Committee (PZED), under the leadership of Council Members Andrea Harrison and Dannielle Glaros, serving as chair and vice chair respectively, made landmark progress in improving our climate for economic development and job creation. The committee moved forward CB-82, CB-83, and CB-84, legislation representing the dramatic reform of the Council's development review process, bringing the desired economic development and jobs to the market. The committee also stated the Council's unequivocal support for a Statewide Sick and Safe Leave Law; adopted zoning provisions that supported the new Regional Medical Center; and worked diligently to move the all-important rewrite of Zoning and Subdivision ordinances forward. The Public Safety and Fiscal Management Committee, led by Chair Obie Patterson and Vice Chair Andrea Harrison, stayed focused on addressing fiscal responsibility and critical economic issues. Through the work of

PSFM, the Council established a Blue Ribbon Commission on Addressing the County's Structural Deficit, and pushed forward important economic tax incentive and tax relief measures, including a major tax incentive for the Suitland Town Center project, a supplemental Renters' Property Tax Credit, and an Urban Agriculture Tax Credit. PSFM committee members include: _____

Under the leadership of Transportation, Housing and Environment Committee (THE) Chair Mary Lehman and Vice Chair Todd Turner, THE served as the Council's "quality of life" committee. THE approved millions of dollars in financing for moderately-priced housing and improved the affordability of senior housing by requiring the option of 24-month leases in many circumstances. The committee also improved environmental protections against foam and coal tar products, and increased funding for bus and taxi service from fees provided by transportation network companies such as Uber or Lyft. Notably, the committee also significantly increased the County's penalties against litter and illegal rentals to \$1,000 per violation. THE committee members include: _____

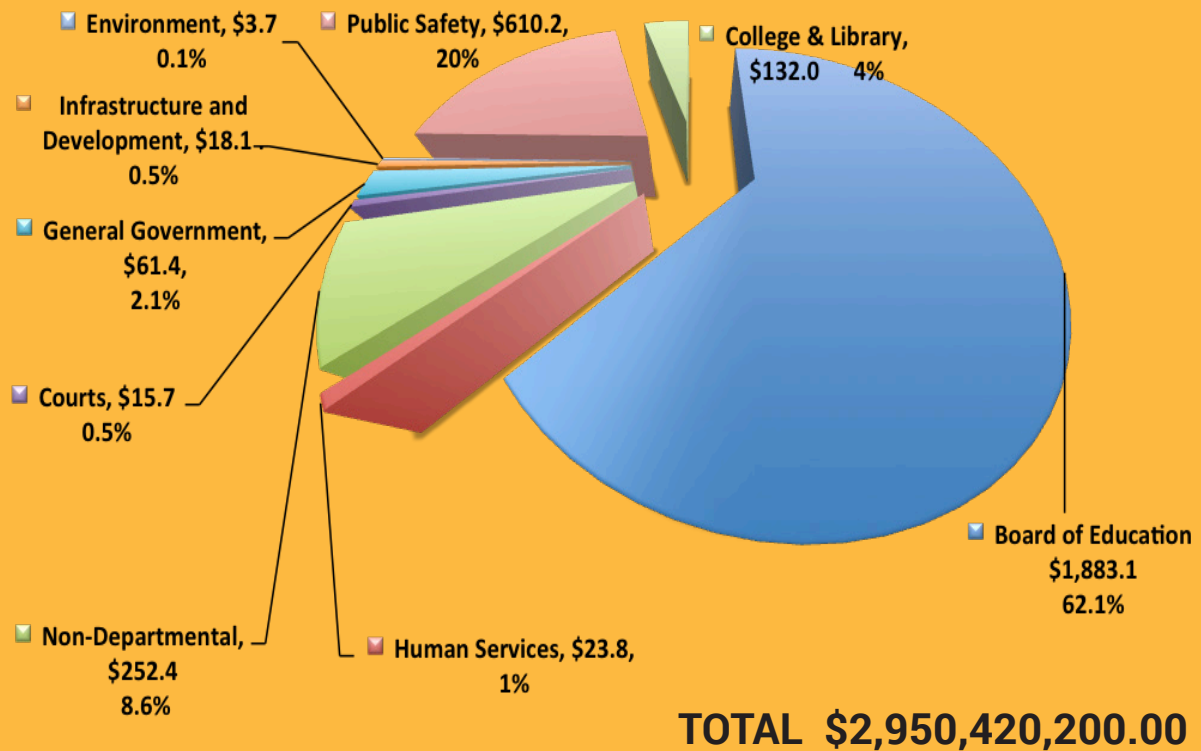
Health, Education and Human Services Committee (HEHS) Chair Karen Toles and Vice Chair Derrick Leon Davis led their committee in the work of establishing food truck hubs in the County and increasing penalties and enforcement on illegal food truck operations. HEHS also conducted approving the transfer of millions of dollars from the fund balance of Prince

George's County Schools to help improve academic achievement. Additionally, this committee explored the important issue of access to mental health services in the County and improved health quality for residents and workers by banning electronic cigarette use in nearly all public establishments.

The Council's Rules and General Assembly Committee, under the leadership of Committee Chair Derrick Leon Davis and Vice-Chair Todd Turner, led the Council's successful Annapolis strategy which worked to protect key state priorities including state funding for the planned, new Regional Medical Center in Largo and securing state approval to proceed with the Purple Line project. The committee gained passage of Council-sponsored legislation authorizing local minority business participation goals for procurement with the School System, and advocated in partnership with the County Executive's legislative team to push for more equitable state funding for public schools under the Bridge to Excellence formula. Rules and General Assembly worked in tandem with Council leadership and our partners across the state to establish the first Large County Coalition through the Maryland Association of Counties to more effectively advocate for the common issues and interests of residents across the State.

FY 2016 COUNTY BUDGET

The Prince George's County Council adopted a \$2.95 Billion FY 2016 County Budget on Thursday, May 28, 2015, funding core public services for County residents and enhancing the Council's management and oversight responsibilities with regard to County spending.



COUNCIL REDUCES PROPOSED TAX INCREASES BY MORE THAN 70%

The FY 2016 County Budget adopted by the Council is more than a 70% reduction of the 15.6% real and personal property tax increases and 4% telecommunications tax increase proposed in the County Executive's spending plan. The adopted budget also invested \$34 Million in additional funding for the Board of Education and Prince George's County Public Schools. The Council approved a measured 4% property tax increase and 1% telecommunications tax increase for the school system, an amount directly tied to the unfunded mandate adopted by the State of Maryland in 2012 which shifted state teacher pension costs – approximately \$30 million in Fiscal Year 2016 and \$42 million in Fiscal Year 2017 - to Prince George's County. Unfunded mandates from the State, which are requirements for spending by County taxpayers without the money to pay for them, create higher costs for families here at home. The Council acknowledges the bold aggression of the Prince George's County Public Schools' Strategic Plan and the County Executive's proposed 15.6% tax increase to support it; however the Council determined that the proposed 15.6% increase in property

taxes was unaffordable for the working families of Prince George's County.

THE COUNCIL INCREASES FISCAL RESPONSIBILITY AND ACCOUNTABILITY

In response to the concerns of County residents expressed during the legislative budget process, the Council, as part of the FY 2016 County Budget action, took additional steps to increase accountability over spending in County Government.

School System Performance Audit for First Time in 18 Years

Education spending consistently comprises over 60% of the County Budget. The County Council and Prince George's County Public Schools (PGCPS) will proceed with an outside Continuous Business Process Improvement Performance Audit of PGCPS for the first time in 18 years. The Performance Audit will study how existing tax dollars are being spent, and recommend potential cost-savings in existing programs. In addition to encouraging improved outcomes in existing school programs, the audit is designed to increase confidence among constituents about the County's public schools system. The Performance Audit is scheduled to begin in the summer of 2015.

New County Spending Control Measures

To address the County's longstanding structural deficit and related fiscal challenges, the County Council adopted a spending control measure requiring each non-education County agency to reserve 2% of their operating budgets and \$6 million of their overtime budgets in a contingency reserve fund. This enables the Council, as the County's fiscal authority, to provide greater assurance that County Government does not exceed the approved budget and provides for funding to address any fiscal emergencies during the fiscal year. Further, this spending control measure avoided any need for furloughs or layoffs of County employees, as proposed in the Executive's spending plan.

Blue Ribbon Commission to Address Prince George's County's Structural Deficit

The County Council approved legislation to create a Blue Ribbon Commission to Address Prince George's County's Structural Deficit. The panel is charged with proposing policies to the County Council and County Executive in the next year that address the County's structural deficit –the imbalance caused when normal government spending exceeds our tax revenues on an annual basis. The Commission is comprised of talented residents and stakeholders with expertise in budget, finance, and public policy.

Reserve 50% of MGM National Harbor Revenue for Education

The County Council also passed legislation requiring that 50% of gaming and direct tax revenue from the MGM National Harbor destination resort be spent on public education -- including the school system, community college, and public libraries -- beginning in Fiscal Year 2017. During the referendum debate on bringing gaming to the County, residents were told that this new project would generate revenue, in large part, for education. This legislation makes the County Government fiscally accountable for that commitment.



FISCAL RESPONSIBILITY FOR PARK AND PLANNING

The County Council message of fiscal responsibility in the FY 2016 County Budget also extended to the Maryland-National Capital Park and Planning Commission (M-NCPPC) (commonly referred to as "Park and Planning") budget, which is also facing a structural deficit of recreation and planning expenses, exceeding revenues on an annual basis. In order to support and sustain many of the existing critical public recreation projects, the Council authorized a one and half cents rate increase. This is approximately half of what Park and Planning indicated was necessary to maintain existing programs and projects, which means a tighter belt for Park and Planning spending as well, particularly regarding planned new recreation projects and planning administration.



THE WORLD IS COMING TO PRINCE GEORGE'S COUNTY

Despite the difficulty of this budget process, this Council is excited about Prince George's County moving forward with such projects as the new Regional Medical Center in Largo, MGM National Harbor Destination Resort, State Department of Housing Headquarters in New Carrollton, and attracting the FBI Headquarters to the County. The World is Coming to Prince George's County and we can all be truly optimistic about what the future holds—world class healthcare, world class education, and an economic development and jobs boom. We remain committed to our posture of fiscal responsibility and accountability, and our shared priority to ensure the economic growth and vitality that Prince George's County residents deserve and expect.

CB-008-2015 AN ORDINANCE CONCERNING RURAL RESIDENTIAL (R-R) ZONE for the purpose of permitting commercial uses in the Rural Residential (R-R) Zone, under certain circumstances.

CB-009-2015 AN ACT CONCERNING SUBTITLE 32 - WATER RESOURCES PROTECTION AND GRADING CODE for the purpose of amending the provisions of the Rain Check Rebate Program, to reflect the intent of CB-86-2014, by modifying the rebate amount for cisterns at residential properties and clarifying language relating to rebates for green roofs.

CB-011-2015 AN ACT CONCERNING THE CLASSIFICATION PLAN FOR PRINCE GEORGE'S COUNTY for the purpose of upgrading existing classes of work.

CB-012-2015 AN ORDINANCE CONCERNING OVERLAY ZONES - USES for the purpose of amending the Zoning Ordinance to clarify that a Hospital is permitted in the Mixed Use - Transportation Oriented (M-X-T) / Development District Overlay (D-D-O) Zones, notwithstanding any other applicable provision of law or comprehensive plan.

CB-013-2015 AN ACT CONCERNING PARKING REGULATIONS for the purpose of prohibiting parking in front of mailboxes in the County and providing for exemptions; and generally relating to parking regulations.

CB-016-2015 AN ACT CONCERNING FOOD SERVICE FACILITIES - MOBILE UNITS - FOOD TRUCK HUBS for the purpose of providing certain limited exemptions to County licensing and health requirements for Food Truck Hubs, in order to encourage economic development, increase public access to healthy food options, minimize or eliminate food deserts in underserved areas of the County, and promote innovative entrepreneurship and revitalization in furtherance of the public safety, health, and welfare of the citizens and residents of Prince George's County

CB-017-2015 AN ACT CONCERNING FOOD SERVICE FACILITIES-MOBILE UNITS-FOOD TRUCK HUBS for the purpose of clarifying fixed locations for food service facilities for temporary periods and providing certain limited exemptions to County licensing and health requirements for Food Truck Hubs in order to encourage economic development, increase public access to healthy food options, minimize or eliminate food deserts in underserved areas of the County.

CB-019-2015 AN ORDINANCE CONCERNING MIXED USE ZONES for the purpose of permitting a group residential facility in the M-X-T (Mixed Use- Transportation Oriented) Zone under certain circumstances.

CB-020-2015 AN ORDINANCE CONCERNING SPECIFIC TEMPORARY USES -EMPLOYMENT OR TRAINING CENTER- R-R (RURAL RESIDENTIAL) ZONE for the purpose of providing for employment or training center as a permitted temporary use in the R-R Zone, under certain circumstances.

CB-021-2015 (SUBDIVISION BILL) - AN ACT CONCERNING SUBDIVISIONS for the purpose of defining Ownership Lot and Parent Lot and providing an exemption from the requirement of a preliminary plan of subdivision for the establishment of Ownership Lots within commercial, industrial, institutional and or multi-family residential lots in certain circumstances.

CB-022-2015 (SUBDIVISION BILL) - AN ACT CONCERNING ADEQUATE PUBLIC FACILITIES AND ROADS for the purpose of amending the findings for adequacy of public facilities and road improvements to permit participation in the funding of roadway improvements under certain circumstances.

CB-023-2015 AN ORDINANCE CONCERNING MIXED USE TRANSPORTATION ORIENTED (M-X-T) ZONE AND COMPREHENSIVE DESIGN ZONES for the purpose of amending the provisions of the M-X-T Zone and the Comprehensive Design Zones to be consistent with the findings for adequate public facilities in Subtitle 24.

CB-024-2015 AN ORDINANCE CONCERNING RESIDENTIAL ZONES for the purpose of permitting artist's studio, barber shop, beauty shop, and medical practitioner's office in certain residential zones under certain circumstances.

CB-025-2015 AN ORDINANCE CONCERNING COMMERCIAL ZONES - VEHICLE, MOBILE HOME, CAMPING TRAILER, and BOAT SALES AND SERVICE for the purpose of permitting Vehicle, Mobile Home, Camping Trailer, and Boat Sales and Service uses in the C-S-C (Commercial Shopping Center) Zone, under certain circumstances.

CB-026-2015 AN ORDINANCE CONCERNING ASSISTED LIVING FACILITIES, CONGREGATE LIVING FACILITIES, AND NURSING OR CARE HOMES IN THE MIXED USE ZONES for the purpose of permitting Assisted Living Facilities, Congregate Living Facilities, and Nursing or Care

Homes in the M-X-T (Mixed Use - Transportation Oriented) and M-X-C (Mixed Use Community) Zones, subject to certain requirements.

CB-027-2015 AN ORDINANCE CONCERNING M-X-T (MIXED USE - TRANSPORTATION ORIENTED) ZONE for the purpose of providing certain alternate development regulations as to the location, density, size, height, and other provisions for buildings and structures in the M-X-T (Mixed Use - Transportation Oriented) Zone, under certain circumstances.

CB-029-2015 AN ACT CONCERNING MINORITY BUSINESS ENTERPRISE CERTIFICATION for the purpose of requiring the decertification of businesses that are improperly certified as minority business enterprises.

CB-030-2015 AN ACT CONCERNING COUNTY-BASED BUSINESS COMPLIANCE for the purpose of establishing an annual Local Business Participation Procurement Report, requiring the report to be annually provided to the County Council and County Executive, and generally relating to County-based business assistance.

CB-031-2015 AN ACT CONCERNING MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION for the purpose of approving the Prince George's County portion of the Maryland-National Capital Park and Planning Commission budget and making appropriations and levying certain taxes for Fiscal Year 2016 for the Maryland-National Capital Park and Planning Commission, pursuant to the provisions of the Land Use Article of the Annotated Code of Maryland, as amended ("Land Use Article").

CB-032-2015 AN ACT CONCERNING FISCAL YEAR 2016 APPROPRIATIONS for the purpose of making appropriations for the support of the County government and for the Prince George's Community College and for the schools, institutions, departments, offices, boards, commissions, and agencies of Prince George's County, and for other purposes, for the fiscal year beginning July 1, 2015, and ending June 30, 2016.

CB-033-2015 AN ACT CONCERNING VIDEO LOTTERY FACILITY FUNDING REQUIREMENTS for the purpose of requiring that fifty percent (50%) of County revenue derived from video lottery facilities be allocated to public education purposes, subject to certain conditions.

CB-034-2015 AN ACT CONCERNING ELECTRONIC CIGARETTE REGULATION for

the purpose of defining electronic cigarettes, regulating distribution, placement and packaging of electronic cigarettes, and restricting smoking of electronic cigarettes inside of public housing, senior citizen housing, and eating and drinking establishments.

CB-035-2015 AN ORDINANCE CONCERNING APPROVED COMPREHENSIVE PLANS, FUNCTIONAL PLANS AND DEVELOPMENT DISTRICT PLANS - MINOR AMENDMENT PROCESS for the purpose of providing a minor plan amendment process for approved comprehensive plans, functional plans, development district plans, and associated approved Development District Overlay (D-D-O) Zones.

CB-036-2015 AN ACT CONCERNING EROSION AND SEDIMENT CONTROL AND STORMWATER MANAGEMENT for the purpose of updating the County's erosion and sediment control regulations to be consistent with the State of Maryland's revised erosion sediment control regulations and the 2011 Maryland Standards and Specifications for Soil Erosion and Sediment Control.

CB-037-2015 AN ACT CONCERNING TELECOMMUNICATION TAX for the purpose of revising the telecommunications tax rate.

CB-038-2015 AN ACT CONCERNING PRINCE GEORGE'S COUNTY RECORDATION TAX RATE for the purpose of setting the recordation tax rate.

CB-039-2015 AN ACT CONCERNING HOTEL AND MOTEL TAXES for the purpose of revising the hotel and motel tax rate.

CB-041-2015 AN ACT CONCERNING DEPARTMENT OF PERMITTING, INSPECTIONS AND ENFORCEMENT for the purpose of adding certain fees; increasing certain fees; amending provisions of the County Code to remove fee references directly from the County Code that fall under Department of Permitting, Inspections and Enforcement; requiring the Department of Permitting, Inspections and Enforcement to publish an annual comprehensive Table of Fees submitted by the County Executive to be approved by the County Council after legislative review and approval by resolution.

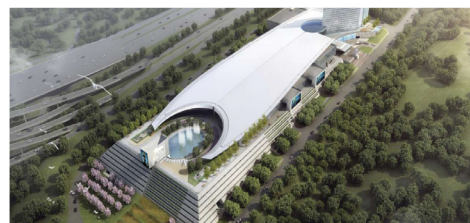

COUNCIL APPROVES LEGISLATION BANNING THE USE OF COAL TAR PRODUCTS IN PRINCE GEORGE'S COUNTY

Council Bill 6-2015, Legislation Aimed at Improving Public Health and Restoring Waterways Adopted In Time for Earth Day – April 22 The Prince George's County Council, during Council session on Tuesday, April 21, unanimously approved Council Bill 6-2015, legislation prohibiting the sale and use of coal tar pavement products in Prince George's County.

Coal tar pavement products are applied to asphalt and concrete to seal and protect parking lots, driveways, recreational trails, airport runways and playgrounds from sunlight, water, debris, chemical spills and leaks. United States Geological Survey studies have identified coal tar based sealcoat as a major source of polycyclic aromatic hydrocarbon (PAH) contamination. Several PAHs are suspected human carcinogens and toxic to aquatic life.

COUNTY COUNCIL INTRODUCES COMPANION LEGISLATION ESTABLISHING FOOD TRUCK HUBS IN PRINCE GEORGE'S COUNTY

Legislation Encourages Economic Development, Innovative Entrepreneurship and Convenient Access to Healthy Food Options

The Prince George's County Council, during Council session on Tuesday, April 21, introduced Council Bill 16-2015, Council Bill 17-2015, and Council Resolution 15-2015, companion legislation proposed by Council Members Dannielle Glaros (D) – District 3, Mary Lehman (D) – District 1 and Karen R. Toles (D) – District 7, establishing Food Truck Hubs in Prince George's County.

Food Truck Hubs, as defined by the legislation, will be outdoor areas designated by the Prince George's County Department of Permitting, Inspections, and Enforcement (DPIE) where two or more mobile units may sell freshly prepared foods, or fresh fruits and vegetables.

COUNCIL APPROVES LEGISLATION PROHIBITING THE USE OF STYROFOAM FOOD SERVICE PRODUCTS

Council Bill Encourages Eco-Friendly Disposable Products

The Prince George's County Council, during Council session on Tuesday, April 28, approved Council Bill 5-2015, legislation prohibiting the sale and use of certain polystyrene products, commonly known as Styrofoam, in Prince George's County.

Under the legislation, Council Bill 5-2015 would prohibit the sale of certain expanded polystyrene food service products and loose fill packaging. The foam form of expanded polystyrene is commonly used to make disposable plates, hot and cold beverage cups, bowls and other items.

Joint Letter also Requests Release of \$15 Million for Regional Medical Center and Support for the Purple Line

The crucial school funding, which received overwhelming bipartisan support in both houses of the General Assembly during the 2015 legislative session, will not require any tax or fee increases, and is solely dedicated to education spending.

Council Bill Supports Disabled Residents; Helps Seniors Age in Place

The Prince George's County Council, during Council session on Tuesday, June 2, 2015, approved Council Bill 7-2015, legislation establishing a property tax credit for the installation of accessibility enhancements on an existing primary residence.

Council Bill 7-2015 provides homeowners with a tax credit equal to 50% of eligible costs, or \$2,500 for an eligible accessibility feature installed on an existing principal residence. Any credit exceeding the annual tax liability of the property may be carried over until the next tax year.

Override Avoids a 15.6 Percent Increase in Property Taxes in Fiscal Year 2016

This evening the County Council voted to override the County Executive's budget veto, preventing a double-digit property tax increase. Residents and businesses have said this double-digit tax increase is unaffordable, and hurtful to our economic recovery.

The County Council, as the Legislative Branch of government, has the legislative authority to override the County Executive's veto of this lawfully enacted budget. CB-33-2015 Ensures County Government Accountability - Earmarks 50-percent of Casino Revenue for Public Education

The Prince George's County Council, during session on Tuesday, July 14, 2015, unanimously adopted CB-33-2015, legislation requiring half of gaming revenue from the MGM National Harbor destination resort be allocated for public education purposes.

Under the new law, 50-percent of annual local gaming revenue, up to a maximum of \$25 million, will now be reserved for Prince George's County Public Schools, Prince George's Community College, and the Prince George's County Memorial Library System, as a part of the County's regular or supplemental budget processes. The law requires that this funding supplement and not replace or supplant existing County funding sources for public education.

PRINCE GEORGE'S COUNTY COUNCIL PRAISES COUNTY'S PURPLE LINE FUNDING DECISION

Prince George's County Increases Purple Line Funding Contribution by \$20 Million

The Prince George's County Council, a strong proponent of the Purple Line, praised today's funding announcement from Prince George's County Executive Rushern L. Baker, III, increasing the County's Purple Line Light Rail contribution to \$120 million.

The Purple Line, a proposed 16-mile light rail line, will extend from Bethesda in Montgomery County to New Carrollton in Prince George's County, providing a direct connection to the Metro Red, Green and Orange lines. Prince George's County will increase its Purple Line Light Rail contribution by \$20 million, for a total of \$120 million in bond and in-kind support from the County. The agreement assures construction of the Purple Line will begin in Prince George's County and the primary command center will also be located in the County.

The Purple Line, which will operate in the corridor between Bethesda in Montgomery County to New Carrollton in Prince George's County, will link key job centers and neighborhoods and strengthen the County's position as a major destination for economic development and job creation.

It is important that our communities reap the rewards of the economic development opportunities the Purple Line will ultimately bring. In Legislative Year 2015, the County and State reached a key funding agreement for the Purple Line, placing this 16-mile light rail project on track to better connect communities and businesses, and create job opportunities for thousands of our residents. The agreement also assures construction will begin in Prince George's County and the primary command center will be located in the County as well.



The County Council works diligently to create and foster a development environment in Prince George's County that maximizes transit-oriented development opportunities by expanding growth opportunities and commercial development.

Recognizing that Prince George's County's prosperity and continued economic growth are directly linked to the adequacy of the County's infrastructure, including our transportation network, the Council has been focused on transit-oriented development, redevelopment, revenue creation and smart growth.

We are home to 15 of the 86 Metrorail stations in the Metropolitan Washington region, and the wealth of undeveloped land around our Metro stations provides boundless opportunities for creative, mixed-used development

Maryland State Department of Housing and Community Development

The Maryland State Department of Housing and Community Development (DHCD), relocated in 2015 to its new home adjacent to the Metro station in New Carrollton, giving our County and region a significant boost in creating high-quality, walkable transit-oriented development. With the move, DHCD became the first state agency headquartered in Prince George's County, and now anchors a multi-phased, mixed-use transit-oriented development project.

M-Square

M-Square, the University of Maryland Research Park and Maryland's largest research park is located just eight miles from the Nation's Capital. Upon full build out, M-Square will cover two million square feet and employ 6,500 people. A dynamic location for science and technology companies, M-Square offers including incubator space for start-up companies and options for larger technology firms. Located adjacent to the College Park – University of Maryland Metro station and College Park MARC Commuter Rail station, M-Square links tenants, university researchers, students, staff and visitors to federal laboratories and private sector companies, and provides easy access to libraries, conference and recreation facilities, world-class performing arts and NCAA Division I athletic events.

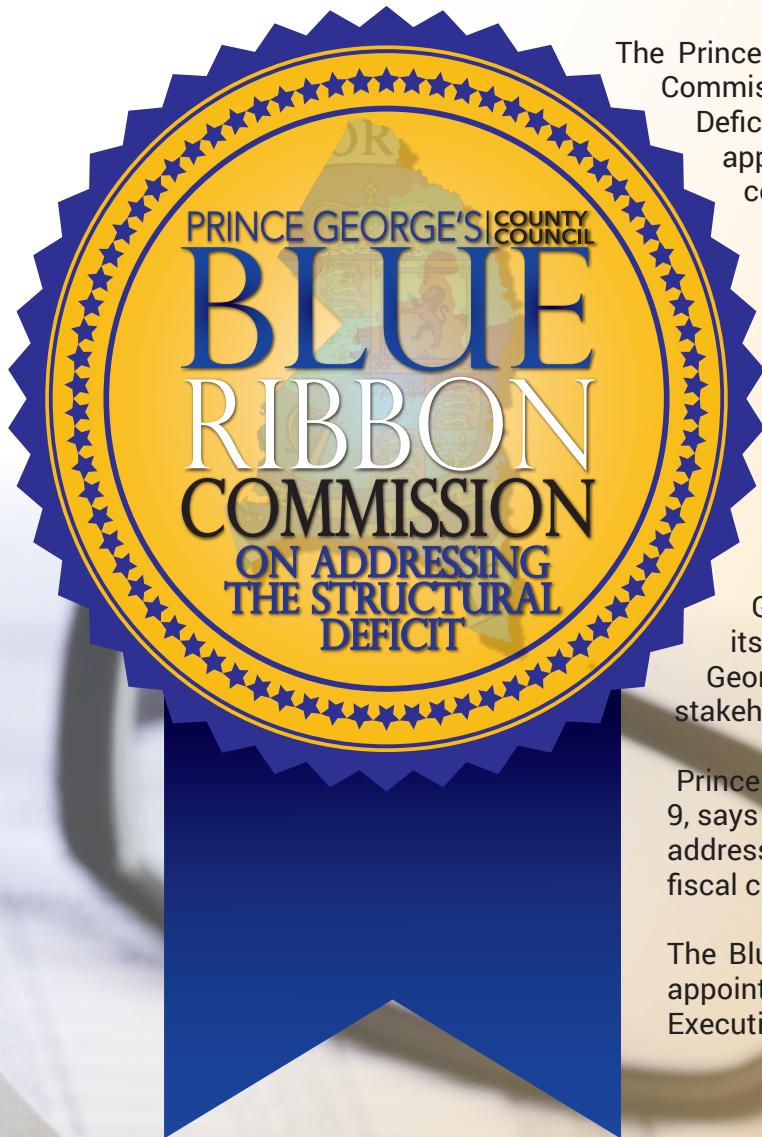

Commission to Address Prince George's County's Structural Deficit and Provide Policy Recommendations to the County Council and County Executive



The Prince George's County Council established the Blue Ribbon Commission on Addressing Prince George's County's Structural Deficit, through Council Resolution 26-2015 as a part of the approved FY 2016 County Budget. The commission will convene for the first time in early September.

The Blue Ribbon Commission is charged with recommending policies to the County Council and County Executive over the next year that will address the County's structural deficit – the imbalance caused when normal government spending exceeds tax revenues on an annual basis. The commission will collect, review and discuss comparative budget data and information regarding Prince George's County's fiscal health; policies and practices that affect Prince George's County's revenue structure and the strength of its tax base; the structure and fiscal dynamics of Prince George's County's government; and feedback from community stakeholders concerning the County's budget and tax structure.

Prince George's County Council Chairman Mel Franklin District 9, says the Blue Ribbon Commission was established to directly address the County's longstanding structural deficit and related fiscal challenges.

The Blue Ribbon Commission consists of 15 voting members appointed by the County Council in consultation with the County Executive.

"Our residents have made it clear that they want a greater level of confidence and accountability about how their tax dollars are being spent, and the establishment of the Blue Ribbon Commission brings us one step closer to that goal. After careful consideration, we have assembled a group of talented Prince George's County residents and experts with considerable expertise in the areas of budget, finance and public policy and look forward to the reports of the Commission and their recommendations in the coming year."

To my fellow Prince Georgians...“We, the People of Prince George’s County,” who we on this dais have all taken a solemn oath to serve, this past year unfolded during a critical time in our County’s history. This has been a critical time of significance and transformation. This past year signaled the end of the era of our County as the region’s bedroom community and the dawning of our time as a destination for people from around the World. It has been a time of continued recovery from the Great Recession and the launching of the \$6 - \$8 billion Prince George’s County Economic Boom. It has been a time of progress marked by continued reductions in crime and improving health care; a stronger environment and moving our budget towards fiscal accountability.

This has also been a critical time for urgency. As Dr. King called it, “the fierce urgency of now.” We must urgently seize the window of opportunity for our County to assume a leadership position in our State and throughout our Region in each and every facet of our quality of life. There simply is no place with the incredible possibilities for progress that we have here in Prince George’s County.

From the \$1.3 Billion MGM National Harbor Destination Resort that rises from the County’s southern gateway, to securing the \$3 Billion Purple Line that will begin its construction right here in Prince George’s County; and from the \$650 Million Regional Medical Center slated for Largo to competing for the \$2 Billion FBI Headquarters in Greenbelt or Landover, our County is doing big things on purpose to create a foundation for change not simply for the next four years, but for the next forty.

This progress is reflected in the leadership and thoughtful work of our Council committees over the past year.

The Council’s Planning, Zoning and Economic Development Committee, under the leadership of Council Members Andrea Harrison and Dannielle Glaros, serving as chair and vice chair respectively, made landmark progress in improving our climate for economic development and job creation. With little fanfare the committee moved forward CB-82, CB-83, and CB-84, legislation representing the most dramatic reform of our development review process in recent memory, creating full certainty in our process to streamline bringing economic development and jobs to the market. The committee also stated the Council’s unequivocal support for a Statewide Sick and Safe Leave Law; adopted zoning provisions that supported the new Regional Medical Center; and worked diligently to move the all-important rewrite of our Zoning and Subdivision ordinances forward.

Addressing fiscal responsibility and critical economic issues were the focus of the Public Safety and Fiscal Management Committee, led by Chair Obie Patterson and Vice Chair Andrea Harrison. The Council has requested restoration of public safety dollars to put more officers on the street and strengthen community policing. The committee also pushed forward important economic tax

incentive and tax relief measures, including a major tax incentive for the Suitland Town Center project, a supplemental renters’ property tax credit, and an urban agriculture tax credit.

Under the leadership of Transportation, Housing and Environment Committee Chair Mary Lehman and Vice Chair Todd Turner, the THE committee lived up to its unofficial mantle as the Council’s “quality of life” committee. The committee approved millions of dollars in financing for moderately-priced housing and improved the affordability of senior housing by requiring the option of 24-month leases in many circumstances. The committee also improved environmental protections against foam and coal tar products and increased funding for bus and taxi service from fees provided by transportation network companies like Uber. Notably, the committee also sent an unequivocally strong message that our property standards will be second to none by significantly increasing the County’s penalties against litter and illegal rentals to \$1000 per violation.

Health, Education and Human Services Committee Chair Karen Toles and Vice Chair Derrick Leon Davis led their committee in the work of tackling the complicated and innovative opportunity provided by establishing food truck hubs in the County and increasing penalties and enforcement on illegal food truck operations. The committee also conducted important oversight over Prince George’s County Public Schools, including approving millions from the School System’s fund balance to improve academic achievement. Additionally, this committee explored the important issue of access to mental health services in the County and improved health quality for residents and workers by banning electronic cigarette use in nearly all public establishments.

And the Council’s Rules and General Assembly Committee, under the leadership of Committee Chair Derrick Leon Davis and Vice-Chair Todd Turner led our Annapolis strategy where we successfully worked to protect key state priorities such as state funding for the new Regional Medical Center in Largo, and securing state approval to proceed with the Purple Line. The committee also worked diligently for passage of Council-sponsored legislation authorizing local minority business participation goals for procurement with the School System, and advocated in partnership with the County Executive’s legislative team to push for more equitable state funding for our public schools under the Bridge to Excellence formula. This committee worked in tandem with Council leadership and our partners

across the state to establish the first Large County Coalition through the Maryland Association of Counties to more effectively advocate for the common issues and interests of residents across the State.

In December 2013, we said the “World is Coming to Prince George’s County.” In December 2014, we spoke about the importance of our commitment to “We, the People of Prince George’s County.” Now, we should embrace that the “World is Watching Prince George’s County.”

I am honored to accept the Gavel of Leadership and to have been chosen by my colleagues to serve as County Council Chair for Legislative Year 2016. I have spent my entire adult life working on behalf of the people of Prince George's County and I am proud to now serve in this capacity.

My promise to you is that I will humbly serve, and do so with integrity. I will give all I have. My leadership of this body and our work together on this Council will leave Prince George's County a better place in which to live, play, and conduct business. County Public Schools, the first in 18 years, creating the foundation for the world-class school system our students deserve, and better inform the decisions of this Council as fiscal stewards.

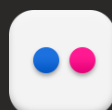

The availability, accessibility and affordability of quality housing for all who desire to live in our County should be among our goals for the future.
