for the period July 1, 2015, through June 30, 2016. Our examination included such tests of the accounting records and such other auditing procedures, as we considered necessary under the circumstances.

We noted no matters involving the Prince George's County grant to Global Vision Foundation, Inc., that led us to believe that the County grant funds were used for other than their intended purpose.

This report, in our opinion, fulfills the requirements of Council Resolution 51-1991 to perform random financial audits of grants and transfer payments made pursuant to the Non-Departmental section of the Prince George's County, Maryland, Fiscal Year 2016 Approved Operating Budget.

**Global Vision Foundation, Inc.**

The Prince George's County Government awarded Global Vision Foundation, Inc., (GVFI) a grant totaling \$65,000 in fiscal year 2016. The grant award was awarded in October 2015, and was to be used to provide healthcare support to underserved citizens located in Capitol Heights, Seat Pleasant, Fairmount Heights, Coral Hills, Peppermill Village, and Walker Mill.

Global Vision Foundation, Inc., is a 501(c) (3) non-profit organization incorporated in 2005, that is committed to serving and assisting in maintaining viable and healthy communities locally and nationally. GVFI headquarters is located at 12108 Early Lilacs Path, Clarksville, Maryland, however they maintain a presence in the County at its office located at 9171 Central Avenue, suites B-11 and B-12, in Capitol Heights, Maryland. GVFI is a self-supported organization that receives funds from grant awards, and fees for medical services provided to individuals. Part of GVFI's mission is to build collaborative global networks of individuals and partner organizations dedicated and united in public service to underprivileged individuals. GVFI fulfills its mission in the County by providing healthcare and health-related education at their Capitol Heights location.

We examined the books and records maintained by Global Vision Foundation, Inc., and included tests of the accounting records and other auditing procedures, as we determined necessary. Our examination included a review of expenditures and supporting documentation to ensure that payment amounts were properly approved and corresponded to related invoices. We noted no instances that led us to believe that County grant funds were used for other than their intended purpose.

GVFI operates and reports on a calendar year, however our examination was conducted on a fiscal year basis. For report purposes, the attached Statement of Revenues and Expenditures is presented on a calendar year consistent with GVFI operations. The Statement of Revenues and Expenditures shows the activities of the organization for the periods ending December 31, 2015, and December 31, 2016. The statement was generated from GVFI's 990 tax return filings and unaudited summary accounting reports. GVFI received County funding for calendar year 2015 and 2016 in the amount of \$105,000 and \$60,000 respectively. Below is a schedule of County grant funding received by GVFI, by award date, which identifies the \$65,000 of grant funding examined by our office.
