Organization Name	Amount	Grant Purpose
100 Black Men of Prince George's County	\$2,500	100 Black Men of Prince George's County will use grant funds for expenses related to supporting its mentoring programs and operations. More specifically, funds will help expand its programs from serving more than 200 youth to at least an additional 50 youth, expanding the service area to blanket the entire county and offering at least one additional field trip to help bring to life what they experience by reading books.
Alliance for Innovation in Education, Inc.	\$3,000	Alliance for Innovation in Education (AIE) will use grant funds for expenses related to paying the registration fees for 30 Prince George's County high school students to participate in its 10-week Youth Technology Immersion Program.
City of Seat Pleasant	\$5,000	City of Seat Pleasant will use grant funds for expenses related to conducting the Home and Health Monitoring Project, a pilot program to allow participating senior citizens who wish to continue living independent lives and age in place.
Coalition of Concerned Black Christian Men	\$1,000	Coalition of Concerned Black Christian Men (CCBCM) will use grant funds for expenses related to providing annual scholarships to eligible Prince George's County high school seniors and to provide food and monetary donations to county families in need of assistance.
Community Builders LTD	\$1,000	Community Builders will use grant funds for expenses related to serving 320 children grades K - 12 and their parents through summer enrichment components designed to foster academic improvement, personal development, healthy lifestyles, employability and family functioning.
Crossland High School Band	\$500	Crossland High School Band will use grant funds for expenses related to purchasing instruments and accessories for use within the band program.
Ebenezer Ame Stone (no website)	\$1,000	Ebenezer AME Stone of Help Community Development Corporation will use grant funds for expenses related to partnering with Ebenezer AME Church's Women's Resource and Restoration Center to provide assistance to women and families in crisis, as well as conducting a young ladies' life skills program to advance their overall well-being.
End Time Harvest Ministries, Inc. - Pathways to Career Success	\$2,000	End Time Harvest Ministries will use grant funds for expenses related to support the outcome-driven Pathways to Career Success program which focuses on on-time graduation, college and workforce / career readiness targeting students at Bladensburg High School, many of whom are residents of District, particularly the Riverdale / Hyattsville areas.
Excellence in Education Foundation for PGCPS, Inc.	\$5,000	Excellence in Education Foundation will use grant funds to support its 10,000 Meals Challenge which will provide breakfast and lunch to Prince George's County Public School students free of charge during the federal government shutdown.
First Generation College Bound	\$3,000	First Generation College Bound will use grant funds for expenses related to general operating support to help support three programs (Homework Club, College Success and College Retention Committee) that will provide services to 1,653 students during the 2018 -2019 academic year.
Game Plan, Inc.	\$2,000	Game Plan will use grant funds for expenses related to providing programming in areas of project management and college and career readiness for Prince George's County public high school students. More specifically, funds will assist Game Plan in providing more program materials and covering travel costs to transport students to / from the Project Management Institute (PMI - Silver Spring Chapter) site (Game Plan's partner organization) in Silver Spring, Maryland.

Gentlemen of Distinction Mentoring Program, Inc. (no website)	\$1,000	Gentlemen of Distinction Mentoring Program will use grant funds for expenses related to supporting the organization's overall program and operation. More specifically, funding will be used for costs to enable the young men to attend field trips, purchase Gentlemen of Distinction tee shirts, bring in speakers and individuals to teach them CPR training and certification, provide food and snacks, and pay for the annual Parent and Guardian Breakfast and student workshops.
Greenbelt Archive Project	\$6,250	Greenbelt Archive Project will use grant funds for expenses related to supporting the digital and physical preservation of the <i>Greenbelt News Review</i> and its predecessor, the <i>Greenbelt Cooperator</i> . More specifically, funds will be used to pay the hourly costs for expert services provided by the University of Maryland (student and faculty consultant / advisor) to ensure the overall standard of the archive.
Maple Springs Community Service Corporation (no website)	\$4,000	Maple Springs Community Service Corporation will use grant funds for expenses related to supporting the six-week summer STEAM Academy that includes instructional training centered on aviation and the Tuskegee Airmen, field trips, art integration, and visiting speakers and presenters. Further, the funding will enable youth from our partnership with Prince George's County Student Youth Employment Program (SYEP) to gain additional experience through our Leadership Institute.
Pi Upsilon Lambda Alpha	\$5,000	Pi Upsilon Lambda Chapter, Alpha Phi Alpha Charitable Foundation will use grant funds for expenses related to offsetting the costs for the children for the Father's Day Breakfast, an event to promote fatherhood and at which prizes will be awarded to the essay contest winners.
Police District V Citizens Advisory Council (no website)	\$1,000	Police District V Citizens Advisory Council will use grant funds for expenses related to supporting its National Night Out event which serves approximately 1,000 citizens from Councilmanic District 9.
Prince George's Tennis & Education Foundation, Inc.	\$1,000	Prince George's Tennis & Education Foundation, Inc. will use grant funds for expenses related to providing college scholarships for its high school graduates and program scholarships for it disadvantaged students.
Student Athletes for Educational Opportunities (SAFE0)	\$1,083	SAFE0 will use grant funds for expenses related to conducting its youth "Healthy Lifestyles" program and offering employment opportunities. More specifically, funds will be used for stipends for four coaches, facility rent, liability insurance, office supplies, sports supplies, transportation, electronic devices, and printing, website, marketing and certificates to conduct the "Youth Employment and Healthy Lifestyle's Basketball Programs."
The Arnold Place (no website)	\$3,000	The Arnold Place will use grant funds for expenses related to paying the rent for Arnold Place as it offers a trauma-informed sanctuary, sensitive to the gender specific, special needs of homeless youth and adult women and the traumas they have experienced.
The Better Family, Inc.	\$5,000	The Better Family, Inc. will use grant funds to support a community based, free admission program (The Tots to Teens Expo) held within Prince George's County.
The Denney House	\$4,000	The Denney House will use grant funds for expenses related to conducting its TDHWorks program to develop in youths ages 16 -24 core competencies related to career, college and financial literacy.
Women Empowered to Achieve the Impossible	\$1,000	Women Empowered To Achieve The Impossible will use grant funds for expenses related to conducting the Entrepreneurship Education Training, Science, Technology, Engineering and Mathematics (E-STEM) education training and the Economic Business Development and Sustainability program.
