Organization Name	Amount	Grant Purpose
Alice Ferguson Foundation	\$300,000	Alice Ferguson Foundation (AFF) will use grant funds for expenses related to conducting its \$300,000 general operating activities, its onsite and offsite environmental education and stewardship programs for students and teachers of Prince George's County.
Bowie Business Innovation Center, Inc.	\$100,000	Bowie Business Innovation Center will use grant funds to cover the salary for the Bowie BIC Director of Operations and a portion of the management fee for the Bowie BIC Executive Director.
Bowie State University Foundation	\$100,000	Bowie State University Foundation will use grant funds for expenses related to providing \$100,000 scholarship funds to eligible Prince George's County high school graduates to cover tuition and fees for new first-time and returning students.
Capital Area Food Bank	\$100,000	Capital Area Food Bank will use grant funds for expenses related to supporting its 32 Afterschool Meals Program sites in Prince George's County; more specifically, funds will be used for staff salaries, benefits, vendor fees and food delivery to execute this program.
City of Seat Pleasant- Smart Cities	\$100,000	City of Seat Pleasant will use grant funds for expenses related to implementing the "My Seat Pleasant" smartphone application and operating the IBM Intelligent Operations Center (IOC) to facilitate and improve public engagement and communication, to provide tools for increasing convenience for citizens and to provide tools for government employees to improve efficiency and track and measure productivity. Increasing citizen's access to their city government will decrease citizen reliance on County services.
Greater Prince George's Business Roundtable, Inc.	\$120,000	Greater Prince George's Business Roundtable will use grant funds for expenses related to meeting and establishing/ enhancing relationships with the leadership at Joint Base Andrews, participating in annual small business summits on base and the biennial Air Shows, and publishing the Prince George's Suite magazine, the only publication in the county focused on lifestyle issues and the news of the day.
Heart of America Foundation	\$150,000	Heart of America Foundation will use grant funds for expenses related to transforming spaces at Parkdale High School and at the Center for Education Partnership in Riverdale to be more conducive to learning, growing and preparing for college and careers. More specifically, a college and career preparation center will be constructed at Parkdale High School. A maker space for creative tool use, a meditation and mindfulness space, and a room for general meetings of the community will be constructed at the Center for Education Partnership facility in Riverdale.
Human Services Coalition of Prince George's County DBA Nonprofit PG Co.	\$50,000	The Human Services Coalition will use grant funds for expenses related to providing information and training, advocacy, networking and collaboration opportunities to Prince George's County's nonprofits.
Meals on Wheels of the College Park Area, Inc.	\$25,000	Meals on Wheels of the College Park Area will use grant funds for expenses related to providing nutritious meals delivered five days a week for eligible seniors and disabled residents of Prince George's County.
Prince George's Arts and Humanities Council, Inc.	\$100,000	Prince George's Arts and Humanities Council will use grant funds for expenses related to providing grants, technical support, artistic programming and creative infrastructure management.
Town of Eagle Harbor	\$100,000	Town of Eagle Harbor will use grant funds for expenses related to renovating its community center.
University of Maryland College Park Foundation/ Incentive Awards Program	\$200,000	University of Maryland College Park Foundation will use grant funds for expenses related to conducting the Incentive Awards Program through scholarships, mentoring, career guidance, monthly community meetings, and other related activities.
University of Maryland College Park- Maryland Small Business Development Center	\$50,000	University of Maryland College Park will use grant funds for expenses related to its Small Business Development Center providing training, counseling and workshops for the small businesses in Prince George's County.
