Derek Anthony Moore Charities, Inc. [DAMCI]	\$10,000	Derek Anthony Moore Charities, Inc. [DAMCI] will use grant funds for expenses related to paying a portion of the program and administrative costs to sponsor and implement existing and expanding programs that will benefit individuals, particularly children and youth, in the targeted districts, specifically Council Districts 3, 4, 5 and 6.
Forestville Boys and Girls Club of Prince George's County Maryland, Inc.	\$20,000	Forestville Boys and Girls Club will use grant funds for expenses related to providing needed services in the community and updating equipment and training aids for members participating in its mentoring through sports program.
Glenarden Unit 275 of The American Legion Auxiliary Department of Maryland	\$10,000	Glenarden Unit 275 will use grant funds for expenses related to providing needed services for veterans, homeless and children in the Glenarden community and the surrounding Prince George's County communities.
Kentland Boxing Association (no website)	\$5,000	Kentland Boxing Association will use grant funds for expenses related to purchasing equipment and uniforms, and for space rentals, travel, accommodations, fees, etc., for approximately 15 20 youth from Landover, Glenarden, Capitol Heights and Seat Pleasant in Prince George's County.
Maryland Cheer Chargers, Inc. (no website)	\$10,000	Maryland Cheer Chargers will use grant funds for expenses related to purchasing a used "spring board" floor and sponsor for competition uniforms.
Mission of Love Charities, Inc.	\$90,000	Mission of Love Charities will use grant funds for expenses related to conducting ongoing programs which provide basic life needs such as clothing, furniture, food and crisis assistance to low income and homeless individuals in Prince George's County.
Prince George's County Department of Police T.E.P., Inc. (Triad, Explorers & PAL) (no website)	\$15,000	Prince George's County Department of Police T.E.P., Inc. (Triad, Explorers & PAL) will use grant funds primarily for expenses related to re-chartering through the Learning for Life and the Boy Scouts of America; tee shirts; training and national competitions; group trips; and recruiting.
Take Charge Juvenile Diversion Program, Inc.	\$50,000	Take Charge Juvenile Diversion Program will use grant funds for expenses related to conducting its program to enhance the safety of the communities served and to provide behavior services to Prince George's County Public School communities that have been affected by poor student performance, disciplinary referrals, truancy and suspensions. The program targets students ages 12 to 16.
The Glenarden Track Club (no website)	\$20,000	The Glenarden Track Club will use grant funds for expenses related to purchasing uniforms for Prince George's County youth participants. Grant funds may also be used for travel expenses.
United Communities Against Poverty, Inc. [UCAP]	\$75,000	United Communities Against Poverty, Inc. [UCAP] will use grant funds for expenses related to general operating support which will allow UCAP to continue providing supportive safety net services for the residents of Prince George's County.
United Communities Against Poverty, Inc. [UCAP] - Shepherd's Cove Women's Shelter	\$11,000	United Communities Against Poverty, Inc. [UCAP] will use grant funds for expenses related to providing supporting services to its Shepherd's Cove Women's Shelter. More specifically, funds will be used to support the food budget for the shelter.
Vision Elite Track Club (no website)	\$10,000	Vision Elite Track Club will use grant funds for expenses related to paying team registration fees for regional and national competitions, purchasing new equipment and / or repairing equipment, and for team travel.
