












Dealing with Upper Marlboro Annexation

Kyle Snyder, Town Administrator, Upper Marlboro:

"We are currently fully in District 9, however, we are currently in the process of annexing areas that would expand the Town limits North and East into District 6. The annexation process should be completed and in effect by October 2021. We just wanted to bring this to the Commission's attention, and check and see if there had been any discussions on the boundaries between 9 and 6 around the Town of Upper Marlboro."

**Note – adding any precincts north and east of Upper Marlboro would lead District 9 to become malapportioned (unless population is subtracted elsewhere)



Submission of Tamara Brown: Avoiding a split of Clinton

“Please keep all of Clinton, MD in Council District 9


Clinton is a Census-designated place that actually has enough infrastructure to be its own municipality including -- a hospital, several medical facilities (County regional medical facility), a post office (own zip code 20735), library, high school, middle school and 4 elementary schools, police precinct, volunteer fire department, historic sites, Regional State Park (Cosca), farmer's market, horse farms, local businesses -- and plenty of residential communities.

Clinton is a homogeneous community of suburban residential neighborhoods. Although Clinton is expanding in terms of residences, the neighbors mostly chose this area to live because of its semi-rural charm that is away from the congestion of more dense areas, yet within mere miles of major corridors (495, 210, 301, Routes 4 and 5) to get to work centers or other metropolitan areas. We share like-mindedness in how we want our communities to look. Our collective thinking does not and should not needlessly be carved up during this 2021 redistricting process. Based on 2020 Census data and the need to add more population to District 8, it is better to include all of Ft. Washington into District 8 than to move any of Clinton residents into District 8. The majority of Ft. Washington is already in District 8....”

Proposed Change for Districts 8 and 9: Move One Precinct (1,466 people) from District 9 to District 8 (*would not affect Clinton*)



A few considerations...

- All changes to plans have consequences and tradeoffs.
- A change made to placate one individual will often seem unfair to another individual or group, who will feel unheard if a change is made without a chance to respond.
- Before we have the census data, most useful suggestions concern whether the existing districts are desirable or not and how projected inequalities between districts should be addressed.
- The Commission process is one step in a process that will continue with the County Council's involvement and final adoption of a plan.
