


# ***MOST COMMONLY RAISED RECOMMENDATIONS***

- Create a certification process for County non-profits/community-based service providers to become properly vetted as official County Re-entry Partners prioritizing the need for data-tracking methods
- Establish a central, online location for all vetted resources that serve returning citizens
- Increase availability of housing options
- Support methods of reliable transportation, particularly for employment purposes
- Expanding the pool of jobs with livable wages available to returning citizens and workforce programs
- Strengthen relationships with the MD DPSCS and DOJ – BOP
- Expanding jail capabilities to allow for space dedicated to addressing mental health/severe mental health needs
- Make the Bridge Center @ Adam's House more accessible to the general public


