

UPDATE ON TENANT LEGAL PROTECTIONS

Supreme Court August 26th ruling invalidated the federal eviction moratorium

Governor's eviction moratorium expired August 15th


CLS of Prince George's County continues to advocate in the Courts for tenants to remain in their home to allow time to complete ERAP applications

Ongoing collaboration with the Office of the Sheriff remains critical

ROFR PROGRAM -- UPDATE

- One property (Hamilton Manor in Hyattsville) was assigned to a ROFR Developer (National Housing Trust Communities) and was successfully purchased in August 2021.
- One property (Doewood/Woodhaven Apartments in Capitol Heights) received County approval for waiver of ROFR process by agreeing to affordability of units via an Affordability Covenant.
- County DHCD intends to issue another RFQ to expand the ROFR Developer Roster.
- County DHCD is looking for ways to strengthen the program's implementation.

ADVANCING AFFORDABLE HOUSING & ARPA SUPPORT

RIGHT OF FIRST REFUSAL (ROFR)

Acquisition Funding targeted for interim acquisition lending pool. Available only in QCTs.

Real Estate PILOT -- HB 1010 was passed in the 2021 State Legislative Session to expand applicability for PILOTs to properties in the ROFR Program in Prince George's County.

HOUSING REHABILITATION ASSISTANCE PROGRAM (HRAP)

\$500,000 to serve households located in the **Purple Line Corridor**, and


\$500,000 to serve households outside of the Corridor

All households must be in a QCT

Eligible **homeowners** earning up to 80% of AMI, prioritization for those earning up to 50% of AMI
