AJF Scholarship & Achievement Foundation, Inc.	\$20,000	AJF Scholarship and Achievement Foundation will use grant funds to enhance education opportunities for those pursuing post-secondary education to include professional certifications. More specifically, grants will be awarded to 21 students who meet the foundation's eligibility requirements.

Autism FYI	\$25,000	Grant funds will be used for Autism Training for Law Enforcement, Fire and EMS and businesses as well as parenting groups, health care and the online program, Immediate Recognition Increases Safety (IRIS) Program for those with autism and other disabilities.
Beltsville Seventh Day Adventist Church	\$70,000	DSS Office at Beltsville Adventist Community Center (Beltsville Seventh Day Adventist Church) will use grant funds to provide emergency rent, utilities, food, mental health counseling, and temporary housing to those in the community who have had a temporary setback (on a case-by-case basis).

Catholic Charities of the Archdiocese of Washington	\$20,000	Catholic Charities of the Archdiocese of Washington will use grant funds for emergency food distributions of free grocery packages and free prepared meals for residents of Prince George's County who are facing extreme food insecurity due to the COVID-19 public health crisis.
Central Kenilworth Ave Revitalization Community Development Corporation, Inc.	\$30,000	Grant funds will be used for expenses such as salaries for program staff, to pay instructors, for supplies and for occupancy to support its holistic workforce development (including culinary arts) program at the Greater Riverdale Empowerment Center / Sarvis Cafe.
Champ House Recovery, Inc.	\$15,000	Champ House Recovery will use grant funds to replace the HVAC systems in its group home.

Christmas in April Prince George's County, Inc.	\$50,000	Christmas in April of Prince George's County grant funds will be used for purchasing materials and supplies for its 2021 event when repairs are made to the homes of selected homeowners.

Coalition of Concerned Black Christian Men	\$35,000	Coalition of Concerned Black Christian Men will use grant funds to support two of their major programs in providing annual scholarships to Prince George's County High school seniors and to provide food & monetary donations to families in need of assistance that live in the County.
Coalitions for Stronger Communities, Inc.	\$25,000	Coalitions for Stronger Communities will use grant funds for expenses related to conducting both virtual and in-person re-entry workshops for women.

Community Crisis Services, Inc.	\$125,000	Grant funds will be used to help with expenses related to Call Center staffing and the two homeless shelters, and increased communications costs due to COVID-19.
Community Forklift	\$75,000	Community Forklift will use grant funds to enhance its community programming (Home Essentials and Community Building Blocks) to support local residents affected by the COVID-19 crisis.
Community Legal Services of Prince George's County, Inc.	\$50,000	Community Legal Services will use grant funds to provide mobile legal services to reach out to underserved areas of the County lacking access to legal services. Legal matters handled include domestic violence, estate planning for seniors, expungement, family law and other civil legal matters.
Community Ministry of Prince George's County, Maryland	\$60,000	Community Ministry of Prince George's County, Maryland, will use grant funds to provide over 575 families or 1,700 individuals monthly food assistance through Community Ministry's Food Assistance Programs and to provide related human services and health referrals to help people navigate the COVID-19 pandemic and other emergencies.
Community Youth Advance, Inc.	\$25,000	Grant funds will be used for expenses related to staffing for programs to keep participation free for children and youth; 10% for overhead expenses.
Congregations United for Compassion & Empowerment, Inc.	\$10,000	Congregations United for Compassion & Empowerment, Inc. will use grant funds for their Prince Georges Plaza Day Center which provides a safe environment including food, warm clothes, showers, laundry, and referrals for homeless and marginal individuals in Prince Georges County.
Court Appointed Special Advocate (CASA) Prince George's County, Inc.	\$100,000	Grant funds will be used to advocate for the physical health, mental health, safe housing, educational and social needs of over 200 youth in County foster care. Funds will also be used for the increased needs due to COVID of youth in care as well as those who come into care as a result of the pandemic.
District Heights (SMHART) Youth Development Foundation	\$50,000	District Heights Family and Youth Services Bureau will use grant funds to maintain and expand its "Your Life Matters" programming which includes two workshops and program expansion.
EcoLatinos, Inc.	\$30,000	EcoLatinos will use grant funds for a program to alleviate Latinos concerns about the COVID-19 vaccine and thus increase rates of vaccination in the community. Conducting effective and culturally sensitive vaccine education means empowering members of the Hispanic community.

The Spanish-language programs will be broadcast throughout Prince George's County by the region's leading Spanish-language station, Telemundo 44.
End Time Harvest Ministries (ETHM) Pathways to Career Success Program	\$75,000	Grant funds will be used to fund the Pathways to Career Success Program, which develops youth academically with a career and college preparation focus, including on-time graduation and preparation for college and workforce entry.
End Time Harvest Ministries (ETHM) Wellness Ambassadors Leadership Program	\$50,000	Grant funds will be used to fund the Wellness Ambassadors Leadership Program, a peer education program where students learn and teach others how to make healthy lifestyle choices.
Engaged Community offshoots, Inc., dba ECO City Farms	\$35,000	Funds will be used to keep safely and securely producing local, healthy and affordable food and to train others to provide essential sustenance in the future.
Family Restoration and Healing Center	\$25,000	Family Restoration and Healing Center will use grant funds to conduct 360 Wholeness Program, educational training sessions, workforce development and counseling. More specifically, the funds will help pay the salaries of those conducting the programs and training.
First Generation College Bound, Inc.	\$150,000	First Generation College Bound will use grant funds for operating expenses related to their mission of inspiring low income and first- generation youth to achieve their social and economic success by providing advice, encouragement, and support to obtain a college degree.
Food & Friends, Inc.	\$100,000	Grant funds will be used to provide medically-tailored, home-delivered meals and groceries to individuals with serious illnesses such HIV / AIDS and cancer that are too ill to buy or prepare food for themselves.
Friends of Greenbelt Theatre (Old Greenbelt Theatre)	\$10,000	Friends of Greenbelt Theatre will use grant funds to support the development of the Media Arts Lab in their newly constructed second screen space.
Friendship Charities Foundation, Inc.	\$50,000	Grant funds will be used to support programs for senior citizens, focusing on health, nutrition and wellness. Funds will also be used to provide tutoring, mentorship, and scholarships to disadvantaged youth in Prince George's County.
Game Plan, Inc.	\$10,000	Funds will be used to provide programming for PGPCS high school students to prepare them for life after high school.
Gateway Community Development Corporation	\$10,000	Gateway Community Development Corporation will use grant funds to expand its capabilities to function within the virtual platform and to supplement operating expenses. They will also be used to purchase updated computer equipment and to hire livestreaming producers.
Gethsemane United Methodist Church	\$10,000	Gethsemane United Methodist Church will use grant funds to support the implementation of two Farmers Markets, and food distribution programs in Healthy Food Priority Areas in Prince George's County.

Jacob's Ladder, Inc.	\$20,000	Jacob's Ladder will use requested grant funds to support their ongoing programs: Diversion, Reentry, COVID Relief, Junior Workforce Academy and Media Relations Division which aim to reduce the number of juveniles entering and returning to the juvenile justice system.

Liberty's Promise, Inc.	\$100,000	Liberty's Promise will use grant funds to support five after-school programs of civic engagement, held at four Prince George's County High Schools (Bladensburg, High Point, Northwestern, and Parkdale), twice annually, either in person or virtually, in 10-week sessions.
Maple Springs Community Services Corporation	\$20,000	Maple Springs Community Services Corporation will use grant funds for a community food distribution program in Capitol Heights, Maryland.
Marlton Swim & Recreation Club, Inc. (no website)	\$55,000	Funds will be used to get through the time period of being closed due to COVID-19 and to complete concrete decking around "splash pad" and other repairs to the facility.
Maryland International Corridor CDC (dba Northern Gateway)	\$25,000	Funds will help Northern Gateway Community Development Corporation maintain its capacity and continue to advocate for the Northern Gateway community through outreach and connecting the community with programs, services and resources that are available in these uncertain times.
Mary's Center for Maternal and Child Care	\$20,000	Funds will allow Mary's Center to continue providing crucial maternal health care to pregnant women at its Adelphi site in Prince George's County.
Meals on Wheels of Takoma Park	\$20,000	Meals on Wheels of Takoma Park will use grant funds for the purchase of food and the preparation of meals for housebound residents in the Prince George's County areas in Chillum, Langley Park and Adelphi.
