FY 2023 Proposed Budget – Key Highlights

- Increased Compensation: Due to annualization of FY 2022 salary adjustments (\$32,300)
- Increased Fringe Benefits: Increase in fringe benefit rate to align with projected costs (\$39,800)
- Increased Operating Cost: Due to an increase in a legal services contract and advertising costs due to a rise in the number of monthly hearings (\$8,000)
- The Board continues to provide alcoholic beverage management services to the citizens, residents, and visitors of the County to promote and maintain quality alcoholic beverage establishments that operate in a manner that benefits the community.
- The Board reported that in FY 2022, it has efficiently processed licenses to produce additional revenue, enhanced the inspection process, and increased customer outreach to reduce license violations. The Board also reports it has increased undercover operations aimed at problematic businesses and modernized the application process to reduce wasted work hours.
- In FY 2021, the Board collected approximately \$1.1 million in revenue for approximately 615 licensed premises in the County. A breakdown of alcoholic beverage licenses by Councilmanic District is provided on page 5 of the full report.

Fiscal Year 2023 Budget Review

Budget Overview

The FY 2023 Proposed Budget for the Board of License Commissioners is \$1,783,800. This represents an increase of \$87,100, or 5.1%, over the FY 2022 Approved Budget. The increase is largely due to the annualization of FY 2022 salary adjustments and an increase in the fringe benefit rate to align with projected costs. The Board of License Commissioners' expenditures are funded entirely by the General Fund.

In FY 2022 the Board expects to make a supplemental budget request of \$45,800 to cover two merit increases for eligible employees and increases in advertising, mileage, and a legal services contract due to increase in number of hearings during FY 2022.

Staffing Changes and Compensation

- FY 2023 compensation is proposed at approximately \$1.1 million, an increase of \$32,300, or 3.0%, above the FY 2022 Approved Budget. This increase is primarily due to the annualization of prior year merit increases.
- The authorized staffing level for the FY 2023 Proposed Budget remains unchanged at nine (9) full-time positions. As of March 10, 2022, the Board reported that eight (8) of the full-time positions are filled. The one (1) vacant position will be funded in FY 2023.
- The FY 2023 Proposed Budget also includes authorization for nineteen (19) part-time positions. This staffing level remains unchanged from the authorized staffing level in FY 2022. The Board reported eight (8) vacant part-time positions as of March 10, 2022. Two (2) of these vacant part-time positions will be funded and six (6) will not be funded in FY 2022.

Fringe Benefit

- Fringe benefit expenditures are proposed to increase by \$39,800, or 10.2%, over the FY 2022 Approved Budget to align with anticipated costs.
- A five-year trend analysis of fringe benefit expenditures is included below.

Operating Expenses

- The FY 2023 operating expenses are proposed at \$228,000, an increase of \$15,000, or 7.0%, over the FY 2022 approved level. The major items comprising operating expenses are as follows:
 - Office Automation \$119,400
 - General & Admin. Contracts 40,000
 - Telephone 20,500
 - General Office Supplies 10,000

- The accompanying table compares the FY 2023 Proposed Budget operating expenditures with the FY 2022 Approved Budget operating expenditures. In three (3) categories, the FY 2023 Proposed Budget increases planned spending from the FY 2022 budget. In seven (7) of the categories, the FY 2023 Proposed Budget level remains unchanged compared to the FY 2022 budget.

- The most significant increase between the FY 2023 Proposed Budget and the FY 2022 Approved Budget is Office Automation (\$7,000 increase), because of an increase in charges by the Office of Information Technology.

Highlights

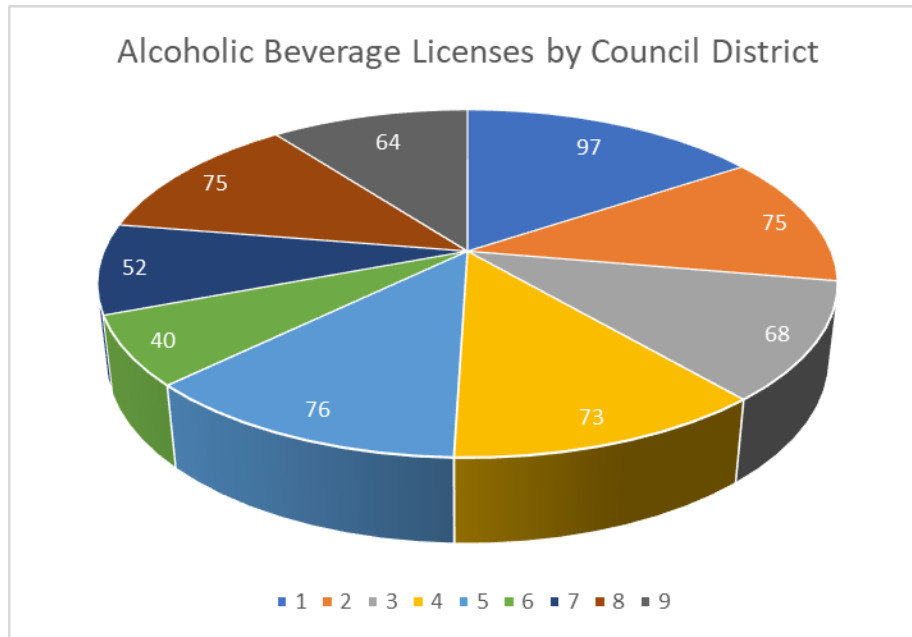
- The Board reported that it has increased the number of underage compliance checks performed and is in the process of developing a “welcome packet” for licensees, a guide to the BOLC Rules and Regulations, to education licensees on the most common violations.
- In FY 2022 (As of February 28, 2022) the Board has adjudicated twenty-one (21) Alcoholic Beverage Violations, with seventeen (17) being adjudicated for Sale to a Minor.
- The Board is working with OIT to improve the automation and efficiency of the alcoholic beverage licensing and inspection process in FY 2022. The goal is to digitize, automate, and streamline the liquor licensing process while also strengthening compliance and enforcement.
- The Board is considering the electronic submission of required documents to facilitate the effectuation process.
- The Board initially experienced a revenue decrease due to the deferment of licensing fees by the Governor. The Board has since recouped those outstanding fees and has returned to their regular renewal schedule.
- The Board plans to increase the level of inspections performed for the Special Entertainment Permit licensees. In FY 2023, the Board plans to conduct 550 Special Entertainment Permit inspections, compared to 465 inspections in FY 2021 and an estimated 500 inspections in FY 2022.
- The Board plans to increase the percentage of establishments with compliant tax accounts with the State of Maryland and Prince George’s County Government. In FY 2023, the Board projects that 100% of the

licensed premises in the County will have compliant tax accounts. This is unchanged from 100% in FY 2021 and the estimated percentage for FY 2022.

- The Board plans to decrease the duration to complete a violation notice hearing. In FY 2023, the Board projects that the days between a violation being written to the time of the hearing is sixty-three (63) days. This is unchanged from sixty-three (63) days in FY 2021 and the estimated days for FY 2022.
- In February of 2022, the Maryland Department of Legislative Services' Office of Legislative Audits completed a performance audit of the Board to evaluate the effectiveness and efficiency of its management practices. The State reported that the Board made improvements from the previous March 2019 audit and addressed 10 out of 17 prior report findings. The report still notes instances the Board did not comply with State law or policy, establish adequate internal controls, and record keeping procedures over certain aspects of its operations in the four areas reviewed:
 - Licensing
 - Inspections
 - Disciplinary Procedures
 - Management Oversight
- The following legislation, which passed the Maryland General Assembly 2021 session, will have a direct impact on the Board's programs and operations.
 - HB0974 – This bill will increase the Board's revenue. An additional \$77,000 would be generated from Class A licenses with thirty (30) establishments eligible for Sunday sales. Class B licenses would generate an additional \$16,200 in revenue with fifteen (15) establishments being eligible. To adjust to the demands created by this bill the Board would need another three (3) Liquor Inspectors to ensure the licenses are compliant. This bill alters the alcoholic beverage licenses for which the Board of License Commissioners for Prince George's County may issue a Sunday off-sale permit; authorizing the Board to issue a Sunday off-sale permit to the holder of any Class A alcoholic beverages license, or to the holder of any Class B alcoholic beverages license with an off-sale privilege; altering a certain reinvestment requirement for an applicant for a Sunday off-sale permit; requiring the Board, by January 1, 2023, to conduct a study of Sunday off-sale permits; etc.
- All five (5) Board Commissioners are appointed by the County Executive, as required by HB 1317, and serve a three-year term. The current Board Commissioners are as follows:

- In FY 2021, the Board collected approximately \$1.1 million in revenue for approximately 615 licensed premises in the County. Below is a breakdown of alcoholic beverage licenses by Councilmanic District. (See Attachment 1 for a description of the types of licenses issued by the Board.) Estimated FY 2022 total

revenues for permits/licenses, administrative fees and fines/penalties are \$2.25 million. The proposed revenue projection for FY 2023 is approximately \$2.3 million.



- The Board projects that revenues for all License and Permit Fees (except Class A), will increase in FY 2023 compared to the FY 2022 estimated revenue, while revenues generated from Administrative Fees and Fines are expected to decrease. See summary of anticipated revenue, by category, below.

Pursuant to Alcoholic Beverage Articles of the Annotated Code of Maryland the Board of License Commissioners is prohibited from issuing any license with an off-sale privilege. All licenses issued are for on the premises sales only.

CLASSES OF LICENSES:

Class A License	Off Sale only, six (6) days a week; No sales of alcoholic beverages on Sunday
Class B License	On Sale seven (7) days for sale of beer and wine, six (6) days for sale of alcohol over 15.5% by volume
Class C License	On Sale only, seven (7) days
Class D License	On Sale, seven (7) days

DESCRIPTION OF CLASS OF LICENSES AND HOURS OF SALES

Class A Beer	Off sale of beer only from 6:00 a.m. to 12:00 midnight, Monday through Saturday. No sales are permitted on Sunday. Consumption on the premises is prohibited.
Class A Beer and Wine	Off sale of beer and wine only from 6:00 a.m. to 12:00 midnight, Monday through Saturday. No sales are permitted on Sunday. Consumption on the premises is prohibited.
Class A Beer, Wine & Liquor	Off sale of beer, wine and liquor from 6:00 a.m. to 12:00 midnight, Monday through Saturday. No sales are permitted on Sunday. Consumption on the premises is prohibited.

Class B, (GC) Beer, Wine & Liquor	On sale consumption from 9:00 a.m. to 10:00 p.m. of beer, wine and liquor seven (7) days a week. Exclusively for the use on the premises of the M-NCPPC golf courses located within Prince George's County.
